

Supervisors Held For Court.

The supervisors of West Pennsboro township, Cumberland County, have been held for court on a charge of neglecting to keep the public roads in their township in such condition as is contemplated by the law, and is necessary to meet the requirements of the traveling public.

Judge Seibert, of Perry county, has not yet named the punishment for three township supervisors who pleaded guilty to not having properly cared for the roads within their districts but his intimation has been that it will be meted out with curative purposes. In defense the supervisors asserted that they were unable to employ help at the prices which the township was able to pay.

Judge Seibert during the trial made the comment that it was the right and duty of supervisors to employ men and teams regardless of cost; that the roads must be kept in safe condition at all times and that if labor cannot be obtained in their own districts. they must go elsewhere, but the
