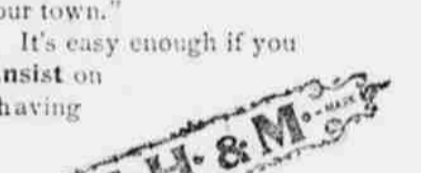

Mr. Spaulding, of Michigan, today introduced a resolution in the House, looking to the admission of the Hawaiian Republic into the United States as a State...

In the House Mr. Livingston asked unanimous consent for the consideration of the following concurrent resolution: That the President of the United States is hereby requested to forthwith ascertain whether Great Britain is advancing her outposts on the territory in dispute between her colony of British Guiana and the republic of Venezuela...

Mr. Wilson, of Wisconsin, introduced a bill which was referred to the Judiciary Committee, withdrawing from the Supreme Court of the United States jurisdiction of criminal cases not capital, and transferring it to the United States court of appeals.

Senate—During the morning hour, on motion of Mr. Voorhees (Dem., Ind.), a resolution was adopted appropriating \$250,000 for the purchase of a portrait of the late Allen G. Thurman...

Mr. Cass—The House gave its time to discussion of the proposed amendments of the rules of the Fifty-first Congress...

Another surprise was brought forth in the debate by Mr. Hepburn (Rep., N.Y.), who made a speech against the usual rule put up in the hands of the speaker...

Mr. Morse (Rep., Mass.) offered a resolution in the House instructing the committee on foreign affairs to inquire into the expediency of reporting to the House and expressing the opinion of the committee in regard to the Armenian outrages...

A communication was received from the secretary of the treasury in reply to a resolution of the Senate adopted by Mr. Foster, which asked whether the gold reserve of \$100,000,000 had ever been a study segregated or set apart from other currency in the treasury...

Mr. Kyle (Rep., Ill.) introduced a concurrent resolution authorizing and directing the President of the United States to resolve such persons as may present themselves, officiously acceding to and acting on behalf of the Cuban patriots...

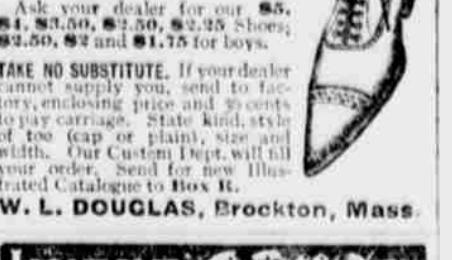

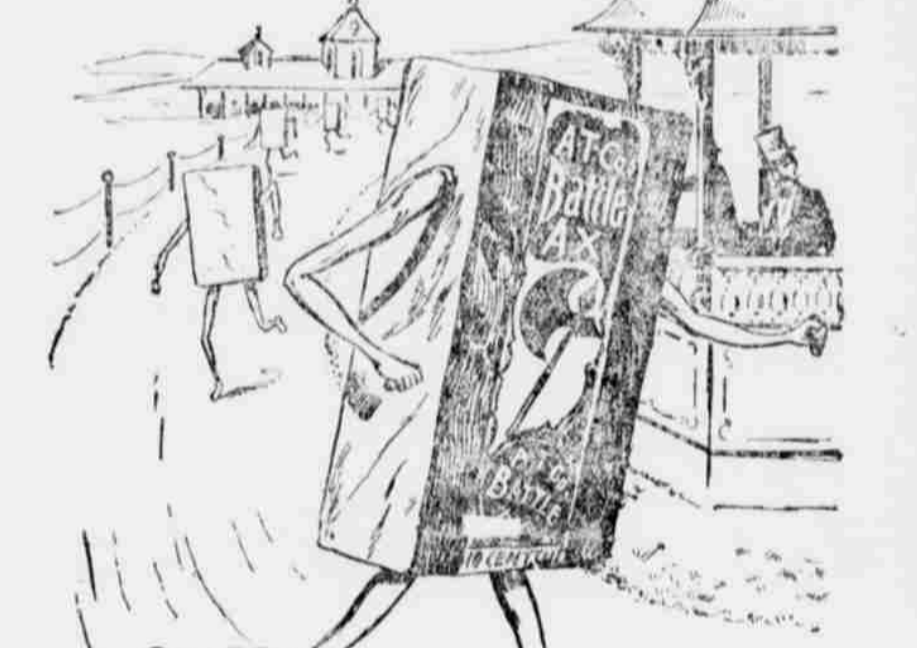
