

But there is a third reason why rapidity of eating interferes with digestion. The pres-ence of the salivary secretion in the stomach acts as a stimulus to the secretion of the gastric place. Irre-spective of the mechanical function of the teeth, food which goes into the stomach incompletely mingled with saliva passes slowly and imperfectly through the process of stomach digestion. Therefore, as a sanitary maxim of no mean value, teach the children to cat slowly, and ample, the teacher, as well as the pupil, may receive benefit,—*Troy Times*.
