

The new conditions will now give us this trade and so benefit our cotton grow-ers and manufacturers, and inci-dentally our whole population. Don't forget this fact during the campaign : Senator Jones, chairman of the Democratic National Committee, offered an amendment to the Porto Rican tariff bill to return the duties on sugar imported from that island "to the persons from whom they were collected." The sugar trust had paid \$637,551 of these duties and if the amendment of the Democratic Senator had not been opposed by the Republicans, than he would have caused the return of that sum to the trust.
