## Diphtheria and Croup.

In a report to the French academy of medicine, Dr. Dethel stated that the vapors of tar and turpentine would dissolve the fibrinous exhalations which choked up the throat in eroup and diphtheria. He describes the process as follows :

Take equal parts (say two tablespoon-9:00: 9:15. fuls) of turpentine and liquid tar, put them into a tin pan or cup and set 9:45. fire to the mixture, taking care to have 10:45. a large pan under it as a safeguard a gainst fire. A dense resinous smoke arises, making the room dark. The patient immediately seems to experience relief; the choking and rattle stop; the

10:80. patient falls into a slumber and seems to enhale the smoke with pleasure. The

## Want Water Works.

Milheim's town council met in extra ession Monday of last week and passed resolutions to submit at the regular election in November the proposition of increasing the borough's indebtedness \$10,000 to be used for water works. The question is not a new one in Milheim for at a special election on Mor. day, September 12, 1898, it was defeated by about fifteen votes. It is the intention of the advocates of the water system to bring the water from Phillips creek, where a good supply of excellent mountain water can be procured, and where a reservoir can be built at a very low cost. Heretofore that town depended entirely on the wells and cis-terns for their supply, which often was a source for contagion.
