Life's Work Ended.

MOYER.

Philip B. Moyer died at his residence in Freeburg on Wednesday morning, at 2 o'clock, from cancer, aged 66 years and 10 months.

Deceased was a son of the late Frederick C. Moyer, and was of a family of nine children, of whom four sisters and two brothers survive. He entered the bonds of matrimony with Miss Sarah S. Hilbish this union was blessed with thirteen children, of whom the following, with his wife, survive him: Chas. D. Moyer, Esq., of Chicago, Misses Anna J., M. Florence, Mrs. Edwin Wagner, Akron, Ohio, Clement, of Chicago, Emma K., John Clifford, Ella L. and Herbert E.

From the effect of a bruise on the nose some twenty years ago a cancerous affection developed, and from which, for the past five years he had suffered with christian fortitude, until death came as a welcome relief.

Mr. Moyer had many estimable characteristics of head and heart. His genial disposition led him to be always at peace with his fellow men, and he was ever ready to lend a helping hand to those in need or requiring his services. Being a Republican in principle, he took an active interest in the affairs of his party, but was never an offensive partisan. He became a member of the Reformed church in early life and remained steadfast in the faith to the end. His place was seldom vacant in the sanctuary. Taking a great interest in music, and possessing a rich tenor voice, he sang for many years in the choir. Living he was dear to his family and friends; dead, he is mourned by all.

The funeral takes place to-day, Friday. The services will be conducted by his pastor, the Rev. W. A. Haas.

The obsequies will be directed by P. L. Hains. The pall-bearers are: Jacob A. Wilt, Francis Glass, J. A. Grimm, H. S. Schneer, P. S. Riegle and John M. Hoffman. Interment in the Fairview cemetery.—Courier.

Bloomburg's Centennial.

Bloomburg, Columbia county, Pa., was founded in 1802, and her citizens are making great preparations for a grand celebration to close the hundredth year since the plotting of the town. The exercises will begin on Wednesday evening, 27th, with a union meeting in the M. E. church, conducted by the clergy, and music by a choir of 100 voices. On the 28th there will be an historical meeting in the morning, a civic parade of secret societies, floats, automobiles, bands, etc., in the afternoon, and band concerts and fire works in the evening. On the 29th is Firemen's Day, with contests in the morning, and a great parade in the afternoon. There will be base ball games, balloon ascensions, a Palace of Illusions, an exhibition of wireless telegraphy, an Historical Museum, beautiful decorations, and many other attractions. Excursion rates have been arranged with all railroads leading to Bloomburg, and it will be one of the grandest demonstrations ever witnessed in this portion of the State.

Choir Convention.

The 15th annual Snyder County Choir Convention was held on the grounds surrounding the Lutheran and Reformed church at Freeburg last Saturday, Prof. Wm. Moyer presiding. The Lutheran and Reformed choirs and singers from the district took the stage and sang the anthem "Guide Me, O Thou Great Jehovah". Prof. F. C. Moyer, of Reading, conductor. Prayer by Rev. J. B. Focht, D. D. The death of Philip B. Moyer occurred August 13 and was announced, he having sung in the congregation and choir for 50 years and had participated at each convention. Suitable addresses were made by County Superintendent Walborn, F. S. Glass, Esq., Wm. Hilbish, of Akron, and the President. Committee on resolutions: H. M. Wiest, John Field, Prof. Sierer. Anthem—"There is a Land Immortal". Program of convention resumed: chorus, "Be Not Afraid" address by Rev. Focht; male quartet, F. C. Moyer, Wiest, Glass and C. W. Bassler, encores. Executive Committee from 8 districts elected W. Moyer, Pres.; G. W. Sierer, V. P.; A. W. Auker, Sec.; Brian Tents, Treas. The third Saturday of August, 1903 was selected for the Sixteenth Annual Choir Convention to be held on the same grounds; F. C. Moyer as conductor. Male quartets and selections from "Judy No. Choir Leader" and Chorus Anthem. The chorus was augmented by Mrs. C. A. Riegle, organist, W. H. Grimm and Brian Tents, violins, W. E. Brown, trombone. The President thanked the press of the county. Audience sang Long Meter Doxology. Benediction by Rev. D. I. Schaeffer. This meeting is pronounced as one of the most interesting sessions ever held in the history of the convention.

Arrested for Stealing.

Francis M. Specht, of this place, and an Ettinger, of Troxelville, were arrested last week for stealing a harness from ex-Sheriff Bolender's stable. Suspicion was turned to them on information furnished by Murray Bowersox who discovered a new harness in a bag on Ettinger's wagon.
