

PASSED ANTI-TRUST BILL

Measure Goes Through the House 3y Unanimous Vote.

Washington, Feb. 9.-By a unanimous vote, 245 to 0, the house Saturday passed the anti-trust bill. The closing chapter was devoid of excitament. For three hours the Democrats offered a series of amendments de signed to place "teeth" in the bill, but they were either ruled out of order or voted down by a strict party vote. On orly one vote were the pollical ranks broken. It was on an amcudment offered by Mr. Thomas (Dem.), of lows, to make the filing of returns incumb at upon all corporations mandatory. On that amendment seven Republicans voted with the Democrats.

The bill as passed requires corporations "hereafter organized" to file returns covering its articles of incorporation, financial composition, comiltion, etc., with the interstate commerce commission on penalty of being restrained from encourse in interst- e commerce, preserious pompting for false returns, etc. The cound-in it given authority in its discretion to cail for similar returns from existing corporations doing an interstate latshared. The commission is given never to compel the answer to questions, and a ringing heal.) and comfort fine of not to exceed \$5,000 is imposed for failure to obey the commission in Liberal Adjustments. this respect. Rebates by carriers is made punishable by a fine of not less than \$1,000, and corporations violating the provisions of this section are forbidden the use of the instrumentalities of interstate commerce. Carriers are prohibited from knowingly transporting articles produced, manufactured or sold in violation of the Sherman act. In cases of prosecutions, no person is excured from testifying on the ground that such testimony would tend to incriminate him, but for such prosecuted. The circuit courts are given jurisdiction in cases of violation, and it is made the duty of district at torneys to institute proceedings to prevent violations and individuals damaged by violations are given authority to sue.

PRESIDENT DECLINES

Mr. Roosevelt Refuses Allies' Invitation to Act as Arbiter.

Washington, Feb. 7. - President Roosevelt has declined the invitation of the allied powers to arbitvate the question as to whether they shall receive preferential treatment in the settlement of their claims against Venezuela over the other creditor nations. He reached this decision yesterday afternoon and instructed Secretary Hay to dispatch a note to the British embassy at once, advising the British ambassador to that effect. The matter, therefore, now will be referred to The Hague tribunal. This will result Harris and one man of the constabulary in the immediate raising of the big Horacy ade.

The Venezuelan envey went at once to the embassy, where the British hinbasydor explained that he had been too ill to call for protocol, which he was prepared to submit to Mr. Bowen for simulation Later the therman minister, flarm Sternberg, called on Mr. Bowon und announced the arrival of his protocol. Today's program includes preliminary preparations for the signing of the protocols. It developed that two protocols are to be signed by Mr. Bowen with the Italian ambassedor, Signa Mayor des Planches; iwo with the British ambassador, and two with the German minister, Baron Spee von Sternburg.




