## PASSED ANTI-TRUST BILL

### Measure Goes Through the House By Unanimous Vote.

Washington, Feb. 9 .- By a unanimous vote, 245 to 0, the house Saturday passed the anti-trust bill. The closing chapter was devoid of excitament. For three hours the Democrats offered a series of amendments de signed to place "teeth" in the bill, but they were either ruled out of order or voted down by a strict party vote. On orly one vote were the policical ranks broken. It was on an amendment offered by Mr. Thomas (Dem.), of lowe, to make the filing of returns incumbent upon all corporations mandatory. On that amendment seven Republicans voted with the Democraty.

The bill as passed requires corporations "hereafter organized" to file returns covering its articles of incorporation, financial composition, coulttion, etc., with the interstate com merce commission on penalty of being restrained from on capital in interstate commerce, prescrib e prunities for false returns, etc. The commission is given authority in its discretion to easi for similar returns (non existing corporations doing an interstate business. The countilsion is given power to compel the answer to questions, and a fine of not to exceed \$5,000 is imposed for failure to obey the commission in Liberal Adjustments. this respect. Robates by carriers is made punishable by a fine of not less the provisions of this section are forbidden the may of the instrumentallties of interstate commerce. Carriers are prohibited from knowingly transporting articles produced, manufactured or sold in violation of the Sherman act. In cases of prosecutions, no person is excused from testifying onthe ground that such testimony would tend to incriminate him, but for such prosecuted. The circuit courts are own up and have children given jurisdiction in cases of violation, and it is made the duty of district at torneys to institute proceedings to prevent violations and individuals damaged by violations are given authority to sue.

### Mr. Roosevelt Refuses Allies' Invitation to Act as Arbiter.

Washington, Feb. 7. - Presid at Roosevelt has declined the invitation of the allied powers to arbitrate the question as to whether they shall receive preferential treatment in the settlement of their claims against Venezuela over the other creditor nastions. He reached this decision yester day afternoon and instructed Secretary Hay to dispatch a note to the British embassy at once, advising the British ambassador to that effect. 
