

MERGER TURNED DOWN

Federal Court at St. Paul Decides Against Securities Company.

THE OPINION WAS UNANIMOUS

Continuation of Northern Pacific and Great Northern Being Declared Illegal and Securities Company Rejected From View of Bank.

St. Paul, April 14.—The U. S. District Court at St. Paul today rendered a unanimous decision in the case of the Northern Securities Company, holding that the merger of the Northern Pacific and Great Northern railroads was illegal under the Sherman anti-trust law.

The court's decision was based on the fact that the merger would result in a monopoly of the railroads in the Northwest.

The court also held that the Securities Company, which was formed to manage the merged railroads, was an illegal trust.
