Whenever any of the qualified elec-tors of this Commonwealth shall be in any active military service, under a requisition from the Presimittary service, under a redustion from the first dent of the United States, or by the authority of the Commonwealth, such electors may exercise the right of suffrage in all elections by the citizens, under such regulations as are or shall be, prescribed by law as fully as it they were present at their usual


