NATIONAL AFFAIRS

For the past few weeks, and especially since Congress has recessed for the summer, one question which has been especially in the public eye is that of further limitation of armaments.

All of which is of course interesting and encouraging. It would seem, however, in light of the cold and hard facts, that one of the real dangers which now confronts this program of further disarmament, is too great a spirit of optimism which may necessarily be followed by a sense of national disappointment calculated to hurl us farther away than ever from the goal which it is desired to reach.

In view of this, therefore, it may be well to point out a few facts which have too often been unheeded or passed over as unimportant. In the first place it is to be conceded that the American government and the American people are in favor of naval limitation, providing always that America keeps a navy as effective as the best, and a navy to which she is entitled by all the rules of the game.
