STATE AID FUR

There are a good many persons who are familiar with the Sprools Good Roads law under which the State Highway in Mahoning township was constructed, who can not understand how State Aid in road building applies to Boroughs and fancy that those persons labor under some misapprehen sion, who advocate the macadamizing of North Mill street under the Good Roads Law. The following section from the Law Providing State Aid in Construction and Maintenance of Public Roads as approved May 1, 1905, will clear up the whole matter and will show how nicely the law applies to that portion of Mill street between Center street and the Borough line, which is just now the only bad section in a long stretch of highway.

Section 17 provides : Where a portion of an important main highway. traversing one or more townships and for the improvement of which according to the provisions of this act application has been made by said township or townships, shall lie within the limits of, or traverse, any borough or boroaghs, and where the failure of said borough or boroughs to improve the said highway would leave a break or unimproved section in a continuous severity if I stooped, or lifted.
