The treatment of the incident of the essuit upon the sail-or of the fallimore is so conclustory and risedly that I am of the opinion that there is good prospect that the differences grow-ing out of that serious affair can now be ad-justed upon terms satisfac ory to this Gov-ernment by the usual methods, and without escale powers from Congress.
