### Free Trip for Old Soldiers.

Adjutant-General Thomas J. Stewart has issued a circular letter to the Grand Army of the Republic, the Loyal Legion, the Union Veteran Legion and the Sons of Veterans relative to the state furnishing free transportation to America, Georgia, to all surviving honorably discharged Pennsylvania soldiers who were confined in Andersonville prison at any time during the War of the Rebellion for the dedication of the state's memorial in the National Cemetery.

The date of the dedication has not yet been fixed. It will likely be in October or November, and Gen. Stewart asks all old soldiers who are entitled to transportation to communicate at once with the Adjutant-General's office in Harrisburg, giving their names, postoffice address (giving town and county), dates of enlistment and discharge, command in which they served, date of capture, and date of release, exchange or escape from Andersonville prison.

### Sad News Concerning One of Our Old Chums.

Mr. Solomon Snyder has received the sad information that his son, James Albert Snyder, lies hopelessly ill at his home in Hebron, Neb., of bright's disease. His death is liable to ensue at any time. ### New Hunting Dog Law.

It is now unlawful to allow a beagle dog or a fox hound to run at large in the country, according to an act which recently became a law through being signed by the governor. The law provides that no hunting dogs shall be permitted to run loose about the country, only from the 1st day of August of every year to the end of the hunting season. This measure will, if enforced, prevent the killing of a large number of small rabbits during the spring and summer months, as well as prevent the damage to field in the springtime by the dogs. It is a measure which will meet with the approval of every hunter who is in favor of the law being enforced, and the farmer will file no objections, either.
