NOTICE OF APPLICATION FOR CHARTER.

Notice is hereby given that an application will be made by C. H. Jennings, George W. Kipp, D. H. Clark, E. F. Kizer, H. H. Maust, John M. Wright, J. L. Barchus, Mial E. Lilley and the Board of Directors of the Somerset and Wayne Electric Railway Company, under the provisions of the Act of Assembly entitled, "An act to provide for the incorporation and government of Street Railway Companies in this Commonwealth," approved May 14th, A. D. 1889, and the amendments thereto for an involuntary corporation to be called "Somerset and Wayne Electric Railway Company," the character and object of which is the construction, maintenance and operation of a street railway for public use in the conveyance of passengers by electric power, the location of street and the same being as follows, viz:—

Beginning at the edge of the Borough of Somerset where Main Street crosses the bridge over Cox's Creek in the Township of Bedford; thence along the Somerset and Bedford Pike to the plank road; thence along said plank road through the Townships of Somerset and Brothersvalley to the Borough line of Berlin; thence by said plank road to Main Street; thence over Main Street to Cross Street; thence over Spring Avenue to Borough line; thence over public road through the Townships of Brothersvalley and Summit to the Borough line of Garrett; thence by way of Beachside; thence along Walker Street to the Borough line of Garrett; thence over Adams Street and private right of way to the public road on the East side of Buffalo Creek in Summit Township; thence over said public road along said public road to Grant Street; thence over Grant Street to Dale Street; thence over Dale Street to Front Street; thence over Front Street to Thomas Street; thence over Thomas Street and private right of way to the public road near Borough line; thence along said public road leading to Salisbury by way of the bridge over the Casselman River to a point near the Borough line of Salisbury; thence over a private right of way to Cross Street; thence over Gay Street to Union Street; thence over Union Street to Depot Street; thence over Depot Street to Iron Bridge at the Borough line of Salisbury; thence returning by parallel track to the place of beginning.

And for these purposes to have, possess and enjoy the rights, benefits and privileges by said Act of Assembly and supplements thereto conferred.

How the Miller and Ogle Fight is Viewed in Fayette County.

The most bitter contest is for Congress. John G. Ogle, the Socialist faction candidate, charges Hon. E. D. Miller, the candidate of the Berkey faction, with running in the interest of Congressman Cooper. Miller declares that this is untrue; that he is a candidate in his own interest; that he has no arrangement with any man and that he will use all honorable means at his command to secure the district nomination. His friends figure out that the Ogle family have held office for 140 years. The Ogle people retort that the Miller family have been pretty well taken care of, Miller now holding a lucrative State office but that they have not ventured quite so exhaustively into the cold figures of the situation as their opponents have, having a just fear of the comparison. Miller is running on a distinct and straightforward platform that is pleasing to the people. He favors the reformer in the popular mind. Ogle presents no pledges, but claims the nomination chiefly because it has been "promised" him. The promise, it is needless to say, was not made by the Republican voters of Somerset county, and they are not bound by it.

Ogle charges that Congressman Cooper "invaded" Somerset county and set up Miller as a candidate against him. In reply to this, Miller's friends say that Ogle has invaded Greene county and tried to set it up for Ogle, but without success. Even if his charge against Cooper be true, they say he is in no position to press it.
