EX-JUDGE WM. J. BAER DEAD.

Hon. W. J. Baer, who served the Somerset-Bedford district as presidentjudge of the courts from 1881 till 1891, died at his home in Somerset, Tuesday

morning, aged 82 years.

Ex-Judge Baer was for many years one of the leading lawyers of Western Pennsylvania. He was also very active in his time in the development of Somerset's mineral resources, being, in fact, one of the pioneers in the development of the coal industries of Somerset county. He was a brother of Geo. F. Baer, president of the Philadelphia & Reading Railway Company. He is survivee by his wife and four dearshtors.

Proposed Maryland Legislation that Looks Good to Us.

"A bill entitled an Act to impose tax of six mills a net ton on all coal mined in Alleghany and Garrett counties upon all corporations engaged in coal mining in said counties, and a tax of forty cents a month upon corporaperson employed therein, etc., to be distributed for relief of dependents upon workmen killed in the line of such employment, was introduced by Senator Shannon, Tuesday.

The bill has been carefully drawn by Hon. David J. Lewis, an ex-State Senator, and based upon the predicate— "Let the Industry Bear the Burden of the Lives it Takes," seems to be the most orderly plan for relief emergencies yet devised. Crystallized into law, it will afford much satisfaction to underground workmen who go to their employment every morning impressed with the deadly risk they incur for themselves and the dependent welfare of their families.

Providing for a relief fund in a way so systematic and considerate, the friends of the bill confidently believe that employers will allege no objection to its enactment into law. Indeed. they feel that it so far appeals to hu-
