TAKEN BY SURPRISE

A Big Battle Will Soon be Fought in Chili. INSURGENTS LAND AN ARMY.

Balmaceda Sends a Large Force to Meet the Enemy.

A Fierce Fight Imminent—On Its Results Will Probably End the War—The Rout of Balmaceda's Forces Will be Followed by the Capture of Valparaiso. The U. S. S. Baltimore in the Harbor.

VALPARAISO, Chili, Aug. 21.—The insurgent army effected a landing early in the morning in Quintero Bay, only twenty miles north of this city. According to the lowest estimate it numbers 8,000 men. It would be nearer the exact figures to say 10,000.

They were brought down from Chile on eight transports, three tugs and four war ships. The point of landing is about fifty miles from Santiago, where Balmaceda's forces, to the number of 10,000, have been stationed.

The Balmacedists have for some time anticipated a movement south on the part of their foes, but they believed that Coquimbo would be the first place attacked.

It now appears that the hovering of the insurgent fleet in the neighborhood of Coquimbo Bay was only a scheme to deceive Balmaceda.

The landing at Quintero Bay was therefore a complete surprise to the President, but as soon as he learned the news he acted promptly. By his command a large force was sent north to meet the enemy.

Admiral Brown, from his flagship, the San Francisco, saw the landing of the insurgents. They are well armed and enthusiastic.

The United States war ship Baltimore is in this harbor. The Esmeralda, commanded by Silva Palma, is just outside the harbor. It is expected that she will be joined at once by the other insurgent war vessels from Quintero Bay. It looks as if, in conjunction with the advance of the land forces upon this city, the fleet will open fire upon the forts that defend this harbor.

It looks as if the most important engagement so far in the history of the present war is about to be fought. Until the present time it has been nearly altogether a battle of words. Now a fierce fight is imminent.

M'GEEVY HAS FLED.
One of the Canadian hoodlums escapes when about to be arrested.

OTTAWA, Ont., Aug. 20.—Sir John Thompson has expressed to a number of political friends his intention, as Minister of Justice, to indict, in the name of the Queen, for public robbery and conspiracy, the whole of the members of the McGreevy hoodlum gang, and the public officials who bribed, providing he is assured by the local authorities that there is a reasonable prospect of finding here a jury above the influence of the hoodlums.

It is considered that this prosecution will save the Government, and that this threatened political crisis at Ottawa will be averted.

QUEBEC, Aug. 21.—Col. Smith, deputy sergeant-at-arms of the House of Commons, arrived here, armed with a warrant for the arrest of Hon. Thomas McGreevy, but the latter had fled. It is said he has gone to Old Orchard Beach, Me.

SHE SCARED A BURGLAR.
Miss Williams' Cool Nerve With a Thief Standing Over Her.

HAMMINGTON, N. J., Aug. 21.—A burglar entered the house of Mrs. E. A. Williams and daughter at 2 a. m. and took from a bureau drawer \$13 in money. A bank check was untouched. The mother and daughter were awakened by the burglar standing over them. He had partly pulled the bed clothes from the foot of the bed, with the apparent design of binding them. On seeing the burglar Miss Williams cried out: "Get out, you tuff! Mother, hand me my pistol!" The thief ran off.

An hour later the house of Mrs. Trowbridge was entered by an open window, but in this case there was a man in the house and the thief made his escape without securing any booty.

\$250,000 Fire in New York.
New York, Aug. 21.—Fire started last night in the grand stand of the athletic grounds of the Young Men's Christian Association on River avenue and quickly spread to the lumber yard and factory of L. H. Rice & Co., manufacturers of toys, which occupy one city block, extending from 150th to 151st street. This immense plant was totally destroyed, entailing a loss estimated at \$250,000. The insurance is but small.

Mr. Foster's Secret Mission.
Mr. McGonigal, Aug. 21.—Hon. John W. Foster came to Mt. McGregor last night on a special train to hold a consultation with the President. He said that he could not tell the nature of his business with the President. Mr. Foster telegraphed the President making the appointment. Private Secretary Balford went to Saratoga to meet him, and they came here on a special train, arriving at 9:40.

Big Failure.
CHICAGO, Aug. 21.—The American Wheel Company, having works throughout Pennsylvania, Indiana, Ohio, Michigan, and other States, have failed. The assets are \$4,100,000. Liabilities, about \$2,000,000. Judge Bloodgett of the Federal District Court has made Noble C. Butler receiver.

Wanted \$30 to Let Her Off.
PITTSBURGH, Pa., Aug. 21.—Susanna Anderson took out a license yesterday for her marriage to John Danzho. Another man obtained a license to marry her a few days ago, but she changed her mind and offered him \$30 to release her. He wanted \$50 and now sues her for larceny.

Grand Naval Review at Bar Harbor.
BAR HARBOR, Me., Aug. 21.—Secretary of the Navy Tracy is reported to have stated that there will be a grand naval review here next week. The white squadron is expected to arrive, and the lower harbor has been cleared for their entry.

SOCIALISTS FRIGHTENED.
Delegates to Brussels Afraid They Won't be Allowed to Return to America.

BRUSSELS, Aug. 21.—Considerable consternation was caused here to-day among some of the American delegates to the Labor Congress, most of whom are not Americans, by a report that the American government intended to take advantage of the absence of such a large number of socialists and anarchists by denying admission to the United States to all of them who are not citizens, on their return.

SIXTY LIVES LOST

Awful Work of the Hurricane at Martinique. NOT A VESSEL THERE ESCAPED.

The Damage Done to Shipping and Property is Stupendous.

All Plantations About the Island Destroyed—Houses and Havens Crushed Out of Existence—Several Persons Went Mad from Fear—The Night Was One of Extreme Terror—Further Details Expected.

PARIS, Aug. 21.—Later official advice just received states that the calamity which has visited Martinique is the most severe since the year 1817. The disaster is said to be equal to the famous cyclone which swept over the island of Antigua in 1871.

So far as can be learned there have been nearly 60 deaths as a result of the hurricane's visitation, but it will be some time before the full extent of the disaster is known.

At Port-de-France alone there have been 12 deaths. At St. Pierre five persons are known to have been killed; at Lamentes 10, Francais 16, Riviere Pilote 3 and at La Trinite 10.

At all the above places large numbers of persons were injured. The damage done to shipping and property is stupendous. About two-fifths of the island was under cultivation and the mountain slopes were covered with forests; all the forests and all the cultivation in the path of the hurricane appear to be swept away and a number of lives lost in the country districts.

The numerous sugar, coffee, cotton and cocoa plantations which have felt the force of the tornado seem to have been utterly destroyed.

Houses and barns, stock houses and stables have been crushed out of existence, and a considerable period must elapse before the island recovers from its terrible visitation.

There was some warning of the approach of the terrible wind, and thus many of the sailors escaped with their lives. But even in this case the loss of life is not known. Some of the vessels appear to have been carried bodily up the beach by the fearful wind and waves; others foundered at their anchorage, and others still alongside their wharves.

GHASTLY HANGING SCENE.

The Victim's Head Was Practically Torn from His Body.

LIVERPOOL, Aug. 21.—A sickening and altogether frightful occurrence marked the execution of John Conway, who was hanged here for the murder of the boy Nicholas Martin.

As Berry, the hangman, was drawing the black cap over Conway's head the latter shouted: "Hold on, I want to say something." Berry replied: "You can't speak now," and was about to proceed with the execution when the criminal, who was in attendance upon the criminal upon the scaffold, hastily interposed, pushed the hangman one side, and held Conway's hand while the condemned man, in broken tones, asked forgiveness for his sins.

Only when the unfortunate wretch had done speaking and when the priest had replied to his plea for forgiveness did the latter permit the hangman to proceed.

The incident caused intense excitement among those present at the hanging, but it was as nothing compared to the horrible scene which was to follow.

In the course of time the drop fell and Conway disappeared from view. Almost immediately afterwards the piteous began to read the confession of the hanging man.

In his confession Conway said that he was intoxicated when he murdered the boy, and that his reason for taking the boy's life was that he had a morbid curiosity to observe the process of dying.

While the priest was reading Conway's confession a tremendous sound was heard from the scaffold, as if a quantity of water was falling.

A hurried investigation was made by the hangman and by the prison officials, and to their horror they found that the sound was caused by blood which was pouring upon the floor from Conway's neck.

Berry, of course, came in for considerable abuse, the terrible hanging being placed to his account alone.

They believe that the horrible hanging will be freely used as an argument in favor of the abolition of hanging, as a means of execution and the substitution of electricity for the rope.

Mr. Gladstone Explains.
LONDON, Aug. 21.—Mr. Gladstone has written for publication a letter denying that he ever knew of Mr. Farnell's secret whereabouts. He says he never communicated with him by letter except at his official address, the House of Commons, as the only means of reaching Mr. Farnell before the census that is now on.

Monument Dedicated at Gettysburg.
GETTYSBURG, Pa., Aug. 21.—The granite monument on Culp's Hill of the 150th New York Infantry Regiment was dedicated during the day. Col. A. R. Smith, of Poughkeepsie, presided, and addresses were made by Colonel Cantine, Chaplains Vassar and Allen and Major George Williams.
