## FIGHTING LABOR UNIONS.

Strikes Disgraceful in Five of the American Axe Company's Factories.

New York, Sep. 1.—The American Axe and Tool Company is composed of nine axe factories, situated at Johnsonville, N. Y.; East Douglas, Mass.; Beaver Falls, Pa.; Cleveland, O.; Mill Hill, Pa.; Gowanda, N. Y.; Bellefonte, Pa., and Ballston Spa, N. Y., and controls about one-half the production of axes in this country. The employees of the first five manufacturing of the American Axe Company have gone on a strike, caused by the efforts of the company to discourage the growth of labor unions.

These factories are the largest and most important ones in the company. The company claims that it will let the shops rot down before allowing the unions to exist in them, and the men declare they will leave the different towns and hunt other work rather than abandon their organization.

The Federation of Labor has agreed to aid the men to the end.

ALMY'S TREASURES.  
What a Search in the Warden Barn Revealed.

HANOVER, N. H., Sep. 1.—A search has been made in Warden's barn, in which the murderer, Frank C. Almy, hid for so long a time without detection, resulted in the finding of the necktie case which Christie Warden gave her murderer as a Christmas gift.

Other articles were found, among them a napkin ring, some pencilled sketches made by Christie, a large braid of the victim's hair, a dozen verses of sentimental poetry, in the murderer's handwriting, and a package of four handkerchiefs marked with the initials "C. W." From the same hiding place were also taken ten unopened cans of salmon, sardines, clams, and corned beef. Besides a bottle half full of Merford rum.

A NOVEL SCHEME.  
Weather Forecasts May Soon Be Disseminated by Locomotive Whistles.

WASHINGTON, Sep. 1.—The Weather Bureau is endeavoring to establish a novel system of weather forecasts. Already the principal railroads of the country have adopted the plan of disseminating weather predictions by displaying signal flags on trains, and the Bureau hopes to extend this system by having locomotives give the signals by means of their whistles.

Professor Harrington, the chief of the weather bureau, has arranged a system of whistle combinations by means of which persons living at a distance from the railroads can receive the forecasts. By repeating such combination a few times with an interval of ten seconds between possibilities of error in reading the forecasts will be avoided, such as may arise from variable winds or failure to hear the warning signal.

Lasters Strike Against a Reduction.

HAVERHILL, Mass., Sep. 1.—About 40 lasters and dealers-out employed at the shoe factory of the Field-Thayer Manufacturing are on strike against a reduction of five cents a case in their work. The Field-Thayer Company have first and second grades under a first grade price list. They now demand that the union give them a second grade list similar to that used at Chick Brothers.

An Important Horse Sale.

New York, Sep. 1.—The product of the Peytona, Hurstbourne and Fenell Stud was sold at auction last evening by Auctioneer William Easton, of Tattersall's. Prominent turfmen from all over the country were present. Bidding was brisk, but in most cases only moderate prices were realized. The total receipts for the yearlings were \$17,375, an average of \$421.30 per head.

## QUIET IN CHILI NOW

Baquedano Acting Temporarily as President.

SEVERAL EXECUTIONS TO-DAY.

Prominent Government Officials to be Shot for Their Part in the Trouble.

Balmaceda Traced to Los Andes—He Escaped Out With His Family and Valuable—Beyond the Reach of the Rebels—Foreign Admirals Refuse to Surrender Refugees.

VALPARAISO, Chili, Sep. 1.—Order is gradually being restored in Chili. Gen. Baquedano has been recognized as President ad interim of the Republic by the members of the Junta here and little doubt is felt but that this action will be ratified by the members now en route from Iquique.

The government troops at Concepcion, Talcahuano and other places have, through their commanding officers, notified the Congressionalist authorities that they have finished fighting, and are ready to obey orders from the Junta and only Caguano promises to make trouble.

All that remains to be done now is to put down the sporadic cases of disorder, being to trial such of the Balmaceda officials as have been guilty of outrageous acts of tyranny and prepare for the elections which will give the Republic an unquestioned constitutional government.

Senator Godoy thinks that Balmaceda has escaped to Buenos Ayres over the Cordillera by way of Los Andes. He left Santiago, according to news received by Senator Godoy, on Saturday morning with six carriages, containing his family and valuables.

Relative to Minister Egan Senator Godoy emphatically declares that every interview had by him with Balmaceda was entirely confined to the question of commercial reciprocity between the United States and Chili. Nothing of personal benefit to Minister Egan was discussed.

More Executions to Come.

Several prominent government officials will be shot to-day after a trial by court martial. Referring to the silver shipment, Senator Godoy says that Balmaceda bought the Italian steamer Aquila at Montevideo. The owners required cash. The United States Navy Department refused to allow the steamer to carry the bullion.

Balmaceda's officials at Coquimbo have cut the English cable there and have refused to surrender and will make a fight. The Estero de la Lynch started for Coquimbo last night. Transports with troops will follow.

The first, and so far the only execution which has the appearance of having been prompted by revenge occurred here yesterday. The Procurator Fiscal, Fas, who prosecuted the cases against the men who were alleged to be in the plot to blow up the torpedo boats Almirante Lynch and Almirante Condell and the transport Imperiale, which resulted in the execution of Cummings and two others, was taken out and shot.

A formal demand for their surrender was made yesterday on Admiral Brown and German Admiral by Intendente Joaquin Walker-Martinez.

After consultation the two naval officers informed Senator Walker-Martinez that they would decline to surrender the men unless proper guarantees were given that their lives would be safe until they had had a fair trial.

The presence of political refugees on board the American and German war ships has been the cause of several conferences and much ill feeling.

## THE SCHEME FELL THROUGH.

Efforts to Take Out \$5,000,000 of the Extended 4-1-2 Bonds a Failure.

NEW YORK, Sep. 1.—The efforts of a couple of bank presidents to arrange for the taking out of \$5,000,000 of the extended 4-1-2 per cent bonds, which fall due to-day, against circulation at 2 per cent—the rate fixed by the government—has not succeeded. Up to last evening only \$1,800,000 had been subscribed for by the banks, and Frederick D. Tappan, president of the National Bank, and one of the parties interested, stated that the scheme had fallen through. Mr. Tappan further said:

"Had the government extended the bonds at 3 1/2 per cent, I have no doubt in my own mind but that the entire \$5,000,000 would have been taken up. There was practically no money in taking the bonds at 2 per cent, against circulation, not more than 61-100 of one per cent."

Decision in the Allegheny Railroad Case.

PITTSBURGH, Sep. 1.—In the United States Court Judge Held has just handed down a decision in the celebrated Allegheny Railroad case. The court declares that the Allegheny Valley Railroad shall be sold in accordance with the manner prayed for by the Pennsylvania Railroad Company. The decision allows the road to be sold without divesting it of the mortgages, except the income mortgages. The holders of income bonds wanted the property sold divested of all mortgages. The decision is a victory for the Pennsylvania Railroad Company.

Hebrew Refugees Still Detained.

New York, Sep. 1.—The large party of Russian Hebrew refugees who landed at the Mergo Office from the Cunard steamer Kuria are still detained by the immigration authorities for further examination as to their physical and financial condition. Many of them are penniless and came here with their families because they had been deceived into believing that they would be welcomed here and provided with homes by this government.

Wants Convicts for Coal Miners.

NASHVILLE, Tenn., Sep. 1.—In his message to the Legislature the Governor incidentally suggests the purchase of undeveloped coal lands, upon which to erect the penitentiary with a view to working the mines with convict labor and selling the coal to the public.

A Murdered Man's Skeleton Found.

FORTVILLE, Pa., Sep. 1.—The skeleton of a man was found in the woods near Lofy yesterday. There was a bullet hole in the back of the skull, which indicated that the man had been murdered. It is thought the body has lain in the woods for over a year.

NEWPORT, R. I., Sep. 1.—One of the last balls of the season was given last evening by Mrs. Robert Garrett at the cottage she is occupying this season of Narragansett events. The affair was one of the most brilliant of the social season.

The Big Niagara Tunnel.  
BUFFALO, N. Y., Sep. 1.—The preliminary work on the big tunnel at Niagara Falls has been completed and the work on the tunnel itself is now going forward rapidly. Of the 3,500 feet to be excavated about 1,175 has been done.
