A SENSATIONAL CASE. Breach of Promise Suit With Some Interesting Developments.

LAWRENCE, Mass., March 11.-One of the most interesting cases ever heard by an Esser County civil court was tried in this city Wednesday before Judge Bond The case is an action of contrast, where by Miss Susan McCarthy, of Haverbill, claims damages to the extent of \$5,000 from Charles M. Colin, a Haverhill jewelar, for breach of promise to marry her.

Plaintiff, who is 55 years old, alleges Finitulit, who is of years out, singles that she has kept steady company with defendant 22 years. During this time defendant made several proposals of marriage, and the final one was accepted, but no marriage ever took place. The parties finally quarreled and parted. Defendant refused to live up to his promise, and also refused to help plaintiff in any way. The defense is a general denial. Defendant Coffin admits living in the

same house with the plaintiff for years He testified that marriage was never con-sidered, and that he never proposed the matter to Miss McCarthy. However, he matter to Miss McCarthy. However, he had given her to understand that a mar-riage would never take place. Had lived nulawfully with plaintif for years as man and mistress and given her presents of money and jeweiry. The case occupied the entire session.

At adjournment, arguments for the plaintiff were being made. Several sen-sational scenes were enacted during the trial Miss McCarthy fainting several times on the stand and while defendant was referring to their unlawful in-

macy. Miss McCarthy never was married but has, however, a pretty daughter 24 years of age, who was one of the plaintiff's principal witnesses. The court room was rowded throughout the day, and even ladles were in attendance.

A BRUTAL FATHER.

The old plan was as accret as the Austra-lap system, and had none of its dis-advantages. It consisted in furnishing a voter with an envelope in which to enclose his ballot.

UXBRIDGE, Mass., March 11.-Ira Ar-nold, of Douglass, was arraigned here yesterday, charged with counterfeiting. A tiger had en-tered the house, carried away and de-voured the child.


