A COWARDLY MURDER.

George Whalen Will be Lynched if Caught and Taken to St. Paul.
St. PAUL, April 4.—Indignation is at a high pitch in St. Paul last night over the murder of George H. Spaulding, a boy of 19 years, at Portage, Wis., shortly before dawn on Saturday morning.
Young Spaulding was the son of Hugh Spaulding, one of St. Paul's leading citizens. Mr. Spaulding arrived here yesterday afternoon with the body of his son and cleared up the mystery of the assassination. He was killed by George Whalen, a young man of 25, whom Spaulding considered one of his warmest friends.
Three or four days ago Whalen coaxed Spaulding to take a trip to Chicago. On Friday Spaulding's father purchased tickets for both young men, gave his son \$25 dollars and a gold watch, and accompanied the pair to the evening train. On the way to Chicago Whalen prevailed on Spaulding to get off the train for a day at Portage. They left the cars at that point at 3:40 in the morning.
After walking a few rods along the track Whalen picked up a broken, jagged coupling pin and beat Spaulding's head into a jelly. Robbing the body of the money and the watch, Whalen took Spaulding's coat and shoes, threw the body into the canal, and made his escape. He had evidently planned the murder several days before. If caught and brought to St. Paul Whalen will be lynched.

STRANGLED TO DEATH.

A Raggicker, Once Beautiful, Meets an Untimely End in Berlin.
BERLIN, April 4.—The dead body of a woman was found in a sack in the area of a villa in the Kaiser Wilhelm strasse last night. She had been strangled, and the marks of fingers were still apparent on her throat. She was identified as a raggicker who was a well-to-do peasant's daughter, and lived with her father in the country until about thirteen years ago.
She ran away with a captain in the reserves named Schall, and left him shortly after her arrival in Berlin for a student whom she subsequently deserted for an attack of the Russian legion.
She lost her beauty through dissipation, and for the last eight years had been a raggicker. She left her room at 6 o'clock in the morning, and was not seen alive afterward, as far as has been learned, by anybody who knew her.

SPURGEON'S UNSELFISH LIFE.

The Great English Divine Gave All His Income Away to Benefit Humanity.
LONDON, April 4.—The announcement that Rev. Dr. Charles H. Spurgeon left only 2,000 pounds when he died will doubtless be as great a surprise in America as it is here. Everybody not intimately acquainted with the celebrated preacher's methods of work supposed him to be possessed of a comfortable fortune. It is doubtful whether any preacher in Europe or in America ever received greater sums of money, and it is certain that none lived a more simple and inexpensive life.
But Dr. Spurgeon merely considered himself the trustee for the poor of all sums that came into his possession. He never considered himself the rightful possessor of the money in his pocket when he met a person in greater need than himself.

Porter Estate Sold.

Boston, April 4.—A large part of the magnificent estate of Asa F. Potter in Cohasset has been bought by Col. Albert A. Pope, of bicycle fame. The terms are not made public. The purchase includes all the property south of the Jerusalem Road, but does not take in that to the north of that famous drive. In the part transferred are the large house occupied by Mr. Potter, the homestead, with the big stable adjoining, and the dwelling known as the Irving A. Evans house, with its stable and a cottage for the servants. There is also the Daggett cottage the first bought by Mr. Potter, with its stable. The large bowling alleys also come into the property bought by Col. Pope.
