ONE THING AT A TIME.

There is no objection to allowing the people of this borough to vote on the question as to whether or not public water works shall be established, but there is a strong objection to steps in\* that direction before the joint commattee renders an accounting. That committee drew a large sum of money out of the borough treasury on the strength of the special election held several years ago and the court has decided that the committee had no right to act under that election. Now then, let that committee account to the Borough Council and the people. The people have a right to know how much was expended, what the money was spent for and what hope, if any, exists for its return.

AT THE mass meeting in Robbins hall Councilman Lamb repeatedly contradicted Councilman Holman when that gentleman stated that he voted to have the electric road paved. If Mr. Lamb will refer to the Borough Council minutes he will find that Morris Wurm, Councilman at that time, made the motion providing that the electric railway should be paved with mountain stone and that the motion was carried by a unanimous vote.

It is true that the case establishes a bad precedent, but our borough cannot afford to'go to the Supreme Court on test issues. A jury has decided that Mr. Fairley is entitled to his claim. If the jury erred it is our misfortune, but the borough cannot be benefitted by a decision of the Supreme Court, whatever it may be. One thing is certain, the borough will never get back what it has or may spend on the


