REV. DIXON AGAIN.

Rev. Thomas Dixon, Jr., made another attack on Tammany Hall and its leaders last Sunday. Among other things he said:

"I have seen in the public press that Joseph Koch's alleged libel prosecution came to a sudden and untimely end a few weeks ago. In fact, it was very sudden. It was painfully sudden.

"Mr. DeLancey Nicoll, the District Attorney of New York, professes to be a much better man than the ordinary, everyday Tammany heeler who gave him the office. Well, he is a good lawyer, a shrewd and polished young man. He knows his business, too. When he gets hold of a red-hot poker he drops it suddenly.

"On the 30th day of June, five days before the date fixed by the court for pleadings in the case, this virtuous young man sneaked into the Court of General Sessions and in my absence, and without any notice to my attorney, dismissed the Koch-Grady-Higgins-Tammany indictment. This was uncanny. It was unfair. It was infamous.

"Note the contrast between the June and July Grand Jury. Francis Higgins, the forerunner of this June Grand Jury, is a Tammany heeler of the most ignorant stamp; in fact, the headman of John J. Scannell, the notorious murderer who is one of the governing committee of Tammany Hall. This fellow was so stupidly ignorant that when I entered the Grand Jury room he could not repeat the simple words required to be spoken of a defendant.

"He afterward immortalized himself by declaring that I never would have been indicted had it not been for the unfavorable impression my personal appearance made on the Grand Jurors. He said that they had expected to see a man dressed in black, whereas I committed the awful offense of appearing before their august body dressed in a gray suit.

"Did criminal stupidity ever reach a sublimer height? I would say to Francis Higgins, lately naturalized from the fiffraff of Ireland, Tammany heeler and headman, that when I wank advice from him about the cut of my coat I'll let him know.

"I have said that Tammany Hall is an organization of criminals. I repeat it with emphasis. In the little coterie of men who compose its real governors are three leaders who were in prison at the same time, charged with murder—Croker, Scannell and Stokes. This is the era of the government of Grant, Croker, Scannell, Stokes, Divver, Grady and Koch. The history of each of these men, plainly written by a fair hand, would be more incredible than a romance.

"I said that Joseph Koch stands indicted for the violation of his oath as a Commissioner and ought to be in the penitentiary. I repeat it, and I brand him before the Mayor who reappointed him with that fact. Against the man personally, apart from his official record, I have nothing to say. But I repeat that his elevation to the chairmanship of the Board of Exacles, with a salary of \$2,000, is a disgrace to the city."

ROUGH ON HARRITY.

GLADSTONE'S VICTORY

His Net Gain Now Reaches Fifty-four.

HE EXPECTS A MAJORITY OF FIFTY.

The Home Rule Issue May Be Postponed Until the Election Laws Are Reformed—Gladstone Considering Such a Plan—His Comments on the Midlothian Vote.

LONDON, July 15.—The totals, so far as the returns have been received, show 248 Conservatives, 235 Liberals, 39 Liberal-Unionists, 11 Anti-Parnellites, 7 Parnellites; net Liberal gain, 54.

Mr. Gladstone and party, who arrived in Braemar last evening, are lodged in the suite of rooms occupied by the German Emperor Frederick in 1887. Mr. Gladstone looks a trifle jaded. He says he expects a majority of fifty. He is evidently mortified by the result in Midlothian. During the journey he constantly referred to the subject, and deplored the fact that any section of Liberal Scotchmen should set religious bigotry above the principle of justice to Ireland.

Mr. Gladstone had a hearty reception at Aberdeen, and cheering crowds accompanied him to the station when he set out for Braemar. In conversation on the subject of the Midlothian election, Mr. Gladstone ascribed his opponent's large vote to the powerful and incessant appeals of the Established Kirk. He said that, notwithstanding these appeals, the result shows that a majority of electors of Midlothian favored disestablishment.

Mr. Gladstone said that the people, in whose good judgment he had entire faith, would teach Parliament how to act in the crisis, and he was confident that the elections would result in a triumph of autonomy.


