CRITCHLOW IN COURT

First of the Homestead Murder Cases on Trial.

PROSECUTION'S CASE OUTLINED

The District Attorney's Address—A Jury Quickly Obtained—Motion to Quash the Indictments Overruled—Story of the Battle Told by a Witness.

HOMESTEAD, Nov. 19.—The first of the Homestead murder cases is now on trial in the criminal court, and is attracting much attention. Judge Kennedy presides. Critchlow is charged with the killing of T. J. Conner on July 6 during the riots at Homestead.

The prosecution is represented by District Attorney Burleigh, Messrs. Patterson, Bobb, Knox, and Beck, and the defense by Messrs. Argo, of Sioux City; Erwin, of St. Paul, Marshall, Montooth, Reardon, Brennan, and Cox.

Counselor W. J. Brennan moved to quash the indictment and also the array of grand jurors because the grand jury had not been impartially drawn, as the slips containing the names of the jury were not uniform, those deposited by Judge Single being of different size and differently folded from those deposited in the box by the jury commissioners.

District Attorney Burleigh replied that the motion to quash was too late. The defendant had pleaded and had thereby waived any right to the motion. Judge Kennedy allowed the filing of the motion, but overruled it.

The jury obtained consists of Peter Roth, John Heron, Jacob Miller, Amos Masher, Christ Wygant, C. S. Eaton, Christ G. Sende, James M. Wright, D. J. Hereley, W. S. Freyvoegel, Burns Wadsworth, and Louis Jackson.

District Attorney Burleigh opened the case for the Commonwealth. He said that this case differed in no respect from any other case, and the duties of the counsel and the jury were exactly the same.

Under the indictment there could be one of four verdicts, murder in the first degree, murder in the second degree, voluntary manslaughter, and not guilty. These he defined at some length, distinguishing as to the law and facts applicable to each. He furthermore said: "We will show that we are not trying treason or anything in connection with the strike. We are simply trying the case against Critchlow for the murder of Conner."

We will show you that Critchlow was present, had a gun on his shoulder, was behind the steel barricade shooting his gun down upon the barges, that he was in such a place as the bullet came from as to cause Conner's wound. We will show you that from the position Critchlow was in he could not discharge his rifle in any other way than toward Conner."

Of the evidence introduced, Dr. McKenna testified as to Conner's wounds. Capt. J. W. Cooper, of the Pinkertons, told of the voyage on the barges on July 6, and described the landing and the battle at the bank. Court then adjourned.

THE TRUMBOURG TRIAL

Defense Presenting the Testimony—Case Goes to the Jury Today.

KINGSTON, N. Y., Nov. 19.—The prosecution has closed its case in the Trumbourg trial and the defense has begun its testimony. The wife of the prisoner was placed upon the stand yesterday and asked as to whether her husband was poked and whether he did not own a summer residence as claimed. The evidence was ruled out.

Witnesses were then sworn as to his character and testified that up to the time of his arrest the accused had borne a fair reputation. The case will be given to the jury today.

No Papal Nuncio for Washington.

Rome, Nov. 19.—Word has reached here that it is reported in the United States that it is the intention of the Pope to open negotiations for the establishment of a Papal legation at Washington after Cleveland is inaugurated. High officials at the Vatican authorize the statement that there is absolutely not a word of truth in the report.

Louise Cabinet Victorious.

PARIS, Nov. 19.—The Loubet Cabinet has triumphed for the present. After a long and exciting debate, the Chamber, by a vote of 319 to 228, decided to discuss the articles of the government bill for the suppression of Anarchist newspapers. There is a consensus of opinion, however, that this merely postpones the fall of the Cabinet.

Howard Sutherland Resigns.

WASHINGTON, Nov. 19.—Howard Sutherland, chief of the Population Division of the Census Office, who was charged with attempting to prevent Democrats from voting at the recent election at Troy, has tendered his resignation to Supt. Forster and it has been accepted.

Re-Nominated for Mayor of Boston.

Boston, Nov. 19.—Mayor Nathan Matthews, Jr. has been re-nominated by the Democratic City Convention. The name of the Hon. Owen A. Galvin was presented but was withdrawn on the facts becoming apparent that Mayor Matthews was the choice of the delegates.
