HAWAII TERRITORY.

The New York Press in speaking of Hawaii says: The action of the people of Hawaii in deposing their Queen and sending representatives to ask for annexation to the United States has excited intense interest abroad. England, France and Germany have long recognized the commercial and strategic value of Hawaii. The dethroned Queen, who sought to overthrow the Hawaiian Constitution and substitute autocratic power for the limited monarchy which has existed in the little island kingdom, is said to have been particularly susceptible to British influence. It is absolutely certain the failure on the part of the United States to take advantage of the action of the Hawaiians will be followed by the seizure of the islands by some European power. In all probability England would be the aggressor.

Such a contingency is not to be thought of. Patriotic Americans of all shades of political opinion can be depended upon to support the government in asserting the paramount right of the United States in Hawaii. So far as its business and real estate are concerned Hawaii is American already. It is owned chiefly by Americans, its commerce is almost entirely with us, and its sentiment is in favor of annexation to this country has been steadily growing in volume for years. It must be remembered that no force of intimidation has been exercised by the United States. The movement to place Hawaii under our flag has been purely voluntary. The facts show that there is no overwhelming public sentiment on the islands in favor of annexation to this country or of a protectorate by the United States. As for the Queen herself, she has forfeited her claims to sovereignty by her attempted usurpation.

The American element is predominant among the foreign population, and, as we have pointed out, American interests are far in the front of all others combined. American coins are the only foreign coins recognized as legal tender equally with Hawaiian money. The islands are bound to us already by enduring ties, and no foreign power can be permitted to lay hands upon them. They are of immense value for naval purposes. Little expenditure would be necessary to establish a Hawaiian naval station that would be practically impregnable. As a factor in promoting the American commerce of the future Hawaii is of the utmost importance. Whether a protectorate or formal annexation is decided upon, one fact is beyond all doubt or question. The Hawaiian Islands cannot be permitted to pass under any but American jurisdiction.

Extensive Manufacturers of Moscow.

PROTEST FROM ENGLAND

She Instructs Her Minister to Make Complaint.

THE QUESTION OF ANNEXATION.

President, Cabinet and Senate said to be favorably disposed. Mr. Harrison approves of Cabinet action in ordering troops ashore at Honolulu. London, Jan. 31.—The British government has instructed Sir Julian Pauncefote, its Minister in Washington, to protest against the action of the United States officials and forces in Hawaii. The protest, it is understood, will be lodged with Secretary of State Foster to-day. To what extent the protest goes cannot be stated now—whether it is restricted to a protest against the action already taken in Honolulu, or whether it goes to the length of protesting in advance against annexation sought for by the representatives of the provisional government now on their way to Washington.

Mr. A. Hoffmann, who is the Charge d'Affaires of the Hawaiian Legation, has received official news confirming the report of a revolution in the Hawaiian Islands and the detachment of Queen Liliuokalani. The Hawaiian representative visited Lord Rosebery at the Foreign Office in London, the situation with him. Lord Rosebery also hinted that England, France and Germany would be likely to consent to the annexation of the Hawaiian Islands by the United States. The Emperor Victoria, King of the Netherlands and the Kaiser of Germany have received despatches from their mother countries a record of recent events. The Evening Times, Tory organ, said last evening that the annexation of Hawaii may result in bringing the United States into foreign relations on a par with some European nation, and that the annexation of Hawaii, and some friction and conflict between them and the English colonies. "American aggression on the Pacific," adds the Globe, "would occasion Australian remonstrance, to which the British would be compelled to listen. The internal affairs of Hawaii will settle themselves the sooner it is more clearly understood that they are not to be made a temptation to the United States to commit a most uncharacteristic act of folly."  
The Fall Mill Gazette, now also a Tory organ, is neutral in its remarks on the question of American annexation of Hawaii, and suggests that it would be interesting to see how the Americans would manage a colony.

APPROVED BY THE PRESIDENT.

Minister Stevens' Action Meets With Mr. Harrison's Approval.  
WASHINGTON, Jan. 31.—The Hawaiian question continues to be the great topic of discussion in official circles. It is pretty clearly indicated that the administration is not in any way lukewarm in the matter, as was at first supposed. The action of the commander of the Boston, against which Great Britain is about to file or has filed, a formal protest, has received the official approval of the President and his Cabinet. The sentiment in favor of annexing Hawaii rapidly spreading. Several members of the Cabinet have expressed themselves as being in favor of accepting the proposition, but as the action necessary to accomplish annexation must come as well from the Legislature as the executive branch of the Government, those declarations do not in themselves amount to more than the expression of opinion of private citizens. The matter will doubtless be considered at the Cabinet meeting to-day, but of course nothing will be decided upon except probably to arrange for the reception of the Hawaiian Association Commissioners upon their arrival in this city Friday. It has been reported that President Harrison is in favor of the annexation of Hawaii. His action on the part taken in the revolution by the United States officials and forces may also be regarded, as proof of the correctness of his report. Although the course pursued by Minister Stevens in ordering the Boston's marines on shore was without explicit instructions from his government, his action has been fully approved by the President.

FLOOD DANGER PASSED.  
Rivers falling and ice moving out. Without doing much damage.  
PITTSBURGH, Jan. 31.—All danger of a flood has passed. The rivers are now falling, and the ice is moving out to the satisfaction of the rivermen, as well as the owners of property along the streams. The only damage was on the Allegheny river near the 10th street bridge, and was caused by immense quantities of ice and debris floating against the lumber pile of Kopp & Voegtli, moored at that point. The heavy lines were cut in two, and the raft was swept down the river. When the wreckage reached the coal floats of Hartley & Henderson, a coal boat partly filled with coal was wrecked and sent to the bottom of the river. A coal float to which the boat was attached was also badly damaged. The loss is estimated at \$30,000.

Twenty-seven Alton Victims So Far.  
ALTON, Ill., Jan. 31.—Twenty-seven victims have now been numbered in the fatalities resulting from the oil explosion at Alton Junction. Yesterday Louis McIntosh and John Burke ended their misery and last night Barney Nicolson of Alton Junction, was the latest of the victims to die. The injured ones are nearly all in a very bad way, and a dozen or more deaths will follow.
