> Chester County Hospital Managers in a Predleament Over a \$10,000 Appropriation-The National Guard of Pennsylvania to Camp at Sanatoga Park-New Postmasters Appointed.

THE STATE IN GENERAL.

WEST CHESTER, June 24 .- The managets of the Chester county hospital, located at this place, are in a predicament decidedly uncomfortable. The recent legislature passed a bill making an appropriation of \$10,000 to the institution. This bill was drawn by R. T. Cornwell, president of the board of managers of the hospital.

Several of the board of managers went to Harrisburg to receive the appropriation from the state treasurer. It was then that the true inwardness of the hill was made known to them, and they returned without

the money This bill states that when the treasurer will make an affidavit that \$5,000 in cash subscriptions have been haid in, besides the cost of the land for the hospital, then, and not till then, shall the appropriation of \$10,000 be paid. W. P. Snarpless, the treasurer, refused to do this. There have been but \$6,000 paid in, and \$4,000 of this was paid for the ground. Consequently but \$2,000 remains, and \$3,000 more is necessary before the treasurer can make the necessary affidavit.




