## GREAT FLOOD DAMAGE.

The Waters of the Columbia River Continue to Rise.

HUNDRED OF MILES INUNDATED.

Crop on the Fertile Bottom Lands Rained, Houses Washed Away and Much Stock Drowned-Rallroad Trame Totally Suspended-Fifty Drowned in Spain.

PORTLAND, Ore., June 2.-The flood in the Columbia continues to increase, and the indications are that the worst is yet to come. Thursday the Upper Columbia at several points was at a standatill, but late reports show that the river is again rising about one foot in twenty-four hours. The river is more than a foot higher than ver before known, and the damage will

The fertile bottom lands along the river rom the Rocky mountains to the sea, a distance of 600 miles, are all inundated. Grops are rained, houses washed away and stock drowned. The flood has come gradually, which has given residents an opportunity of move household goods to places of safety, and in most instances stock has been driven to higher ground. The salmon canning bysiness has been The salmon canning business has been almost annihilated. Fish and canning establishments along the river for a disance of 200 miles are under water.

Telegraphic communication to the north and east is cut off, except by a roundabout way. Along the Union Pacific from this city to Umatilla, about twenty miles of track are under water. They have estab-lished steamboat service which enables them to carry the mails and passengers. The Northern Pacific does not attempt to operate its line between this city and Goble, a distance of forty miles, but makes connection by the large transfer boat.

In this city the water has risen into assements as far back as Ninth street and more than half the elevators in the city are stopped for want of power. Today's mails from The Dalles brings the information that the government locks at the Cascades are in danger.

Sauvies Island, a few miles below Portland, is almost entirely under water Many buildings are affoat. Crops are ruined and other property is damaged. The losses will aggragate \$250,000.

### Fifty Drowned in a Flood.

MADRID, June 2 .- The river Segrie, to the province of Lerida, swollen by recent heavy rains, suddenly swept over the Sec de Urgel road yesterday, destroying an inn and a warehouse. The bodies of fif-teen drowned persons have already been recovered, and it is believed that fifty people lost their lives by this rise in the river. In addition to the many people drowned, a large number of cattle and a considerable amount of produce have been

### Towns Carried Away.

BOTLDER, Colo., June 2.-Fifty bridges between here and the mountains have been carried away. The towns of Copper Rock and Sugar Loaf are gone, the Prussian and Corning mills flooded, and six of their outbuildings swept down the canyon. Springdale and Jamestown suffered greatly, but no particulars can be had ex-cept that the Springdale hotel is in ruins. Several other small towns along the can-you have been partly destroyed.

## Great Storm Damage.

IDAHO SPRINGS, Colo., June 2. - The damage by the flood in this county is estimated at \$100,000. The storm was the longest and most disastrons in the memory of the oldest inhabitants. ## Importing Coke Workers.

SCOTTDALE, Pa., June 2. - Seven carloads of non-union men were brought into the region by special train yesterday. There were 568 men in all, principally colored men from West Virginia. The Italian labor agent who brought the men here was assaulted last night by strikers and terribly beaten. John Stellen, a roadman at the Variey works, came to town here last night. He was set upon by strikers, and had to be rescued by the police. Dep-uties had to be called from the Valley plant to take him home. The operators are giving more evidence every day of a determination to run.

Tobacco Contracts with France. BALTIMORE, June 2.—The tobacco contract of the French government was awarded yesterday in Paris, and the names of the successful bidders were received here by cablegram. The contract for 4,200,000 kilogrammes of Maryland to-bacco was divided between A. Schumaker & Co. and Henry Lantz & Co., the former receiving the contract for two-thirds and the latter one-third. It will require 13,000 or 14,000 hogsheads of the Maryland crop to supply this year's contract. The con-tract for 900,000 kilogrammes of Ohio to-bacco was awarded to J. D. Kremelberg & Co.


