STRUCK BY A TRAIN.

A Hungarian Dies From Injuries Sustained This Morning.

Andrew Saroko, a Hungarian, 35 years of age, was struck by an east-bound miners' train on the Lehigh Valley railroad, at the foot of West street, at about six o'clock this morning, while on his way to work in the mines. The crew of the train stated that the man became bewildered and stepped in front of the train.

The train was stopped and the crew took the injured man to the Lehigh Valley depot. He was subsequently sent to the Miners' Hospital but died on the way. His skull was badly fractured and his back broken. The body was sent back here on the nine o'clock Lehigh Valley train. It remained unclaimed at the depot for several hours. Saroko lived with his wife on "the rocks" until last Saturday, when they moved to the First ward, and the recent change of residence caused some trouble in locating the widow. The poor woman was prostrated when informed of her husband's death. All the time his body lay in the depot she supposed her husband was at work in the mines. The couple had no children.
