NO PROOFS OF MURDER AS YET.

The Prisoner's Willingness to be Taken to Philadelphia Seems to Verify the Statement That He Substituted Another Body for That of Pitzell.

H. Holmes in Boston. An hour later a tele-gram was received from St. Louis that Howe was in custody, and that the arrest had been made by the chief of polleu in person. erson. Very meager details have been received

in Philadelphia regarding the arrest of Mrs. Pitzell in Boston, but First Vice President McKnight says it was the logteal outcome of Holmes' arrest and con fession.

"I have not yet been informed," said Mr. McKnight, "of the nature of Mrs. Pitzell's confession. My information is simply to the effect that she has been arrested and has confessed. Whether this will throw any light upon the murder theory or whether it will simply be a substantiation of Holmes' story I am not in a position to say, but I suspect it will be the latter." Vice President McKnight does not insist

that Pitzell was murdered, and President Fouse's appearance before the grand jury Fonse's appearance before the grand jury did not so charge, but they and other of-ficial of the company think that the prose-cution and developments of the conspiracy case will develop that blood was spilled and that Pitzell was the victim. The question that remains unsettled is whether the body found at 1316 Callowhill street was or was not Pitzell's. While the insurance company people are inclined to

insurance company reople are inclined to believe that it was, there is no proof to that effect. The police officials are of the same mind as the company's. It is, how-ever, agreed by others that if Holmes was a guilty party to murder he would hardly elect to come to Philadelphia in preference to going to Texas, where he is under in-dictment for horse stealing. Holmes' willingness to come here would

seem to indicate that he is in a position to establish his innocence of any capital crime in Pennsylvania and that he prefers a term of imprisonment for conspiracy rather than a more serious punishment for any other offense committed elsewhere

BOSTON, Nov. 20.-H. H. Holmes, the al-leged life insurance swindler, was removed from the city prision to police headquart-ers yesterday, where his photograph and measurements were taken. In a private room his confession was taken down by a stenographer, to be reproduced in court in Philadelphia. He was careful not to implicate any one except himself, and he stated positively that the body found in the room at Philadelphia was not that of P. F. Pitzell, the insured man, but a corpse II.  Howe Says He Acted in Good Faith. St. Louis, Nov. 20. -Jeptha D. Howe, an attorney having an office with McDonald & Howe, of this city, was arrested on the charge of conspiring with one H. H. Holmes, to defraud the Fidelity Mutual Life Insurance company, of Philadelphia, out of \$10,000. Howe, who was released on \$1,000 hall, made this statement: "I believe the body identified by Pitzell's 15 year-old daughter was that of her father. The marks of identification were perfect. As to how Pitzell met his death 1 cannot say, but if a fraud has been committed 1 am as anxious to have it investigated as anyone, and will do all in my power to bring the guilty to punishment. I took the case in good faith and acted as any at-torney would have done." Mr. Howe says he has no fear of his case, but dislikes the notoriety it gives him.

### Da Gama Still Belligerent.



The appointment of Senhor Barbosa as gov-ernor of the state of Rio Grande do Sul is regarded as proof of the continuance by President Moraes of ex President Peixoto's policy. Admiral da Gama says he has 7,000 men on the Rio Grande do Sul fron-tier who are ready to commence hostilities forthwith.




