

THE ACCUSED CAPTAINS



Allaire and Strauss Again Before the Investigators.

BOTH MAKE GENERAL DENIALS.

Superintendent Byrnes Not Yet Called Before the Committee, but He Will Probably be Subpoenaed Soon—Suspected Efforts to Hamper the Inquisition.

NEW YORK, Dec. 21.—Police Commissioner William J. Mooney, formerly attached to Captain Crockett's command, yesterday testified before the Lexow committee that Reppenhagen had told him that ex-Assemblyman Martin and Police Commissioner Voorhis were each to receive \$5,000 of the \$15,000 paid by Captain Crockett to secure his appointment. The remaining \$5,000, Reppenhagen said, was for himself.

Among the interested spectators at the session were Mayor Fisher of Grand Rapids, Michigan; Rev. Dr. Parkhurst was there, and full of indignation because of the failure up to this time to call Superintendent Byrnes to the witness stand.

Before the session Mr. Goff and Senator Lexow had a conference outside the court room. When they entered the room Dr. Parkhurst held short but earnest consultation with Mr. Goff. When the conference was ended they both shook hands cordially, and the doctor wore a confident smile. It is understood that Mr. Byrnes will be called today or tomorrow.

Police Captain Strauss, like Captain Allaire, who testified before the committee Wednesday and yesterday, made a flat denial of all the charges Lawyer Goff hurled against him. He denied positively that he had ever paid a cent for his appointment as captain, and knew nothing whatever about the collection of blackmail in his precinct. He admitted having promised to make Police Commissioner Wallerstein, a cousin of his, a wardman if he secured his appointment as captain, and that he had borrowed \$2,000 from that officer a few days before his appointment was made.

From questions asked by Mr. Goff it was inferred that a plan had been agreed upon by taking the efforts of Goff to get up higher by checking refuse either in denial or apparent loss of memory.

Mrs. Strauss, wife of the captain, was among the witnesses examined. She said she had not spoken to her husband regarding the testimony she was to give, and denied that she owned any stocks or bonds. She identified Police Commissioner Wallerstein as a relative of her husband.

Refuse to Advise a Strike.

PITTSBURGH, Dec. 21.—The miners of this district who have been in convention for the past three days adjourned without taking the responsibility of advising a strike against the fifty-five cent scale. Resolutions were passed demanding sixty-two cents for mining; that all dead work shall be paid without any reduction on the present dead work scale; that the scales be made uniform; that miners shall be paid in full cash every two weeks; and that the company stores be abolished, and that the check weightman be paid like the other miners. The above resolutions are to be presented to their respective locals by the delegates, that a vote may be taken. In the meantime individual miners may work at the fifty-five cent rate if they choose.

Threatened Strike of Street Car Men.

NEWARK, N. J., Dec. 21.—As yet there has been no strike, as threatened by the employees of the Consolidated Traction company. The leaders of the motormen and conductors, many of whom are members of the Knights of Labor, declare that a general strike will be inaugurated after the beginning of the year if an increase of wages is not forthcoming. General Manager David Young said: "We do not care whether or not our men belong to the Knights of Labor. If they attempt to tie up the road it will be a fight to a finish."

Dunraven's Demands Conceded.

NEW YORK, Dec. 21.—The America's cup committee met at the office of Commodore Smith to consider the latest proposition sent by Lord Dunraven by cable. Lord Dunraven's proposition is understood to remove the objection to signing the receipt in case his yacht wins. He insists, however, on having the race earlier than the ten months' clause permits. A cablegram was sent to Lord Dunraven which practically concedes all his demands. A race is now deemed certain.

Assaulted for an Act of Charity.

CAMDEN, N. J., Dec. 21.—Benjamin Elliott, colored, was stabbed in the back and cut about the head by James Chambers, also colored. Chambers escaped, and Elliott, who is in the Cooper hospital, may not recover. Chambers, while intoxicated, beat his wife and drove her and the child from the house, threatening to kill them if they returned. Elliott gave Mrs. Chambers shelter, and for this Chambers assaulted him.

Earthquake in Hungary.

BUDA PESTH, Dec. 21.—The town of Oravica, about fifty miles southeast of Temesvar, was visited by a violent shock of earthquake which wrecked a large number of houses. Roofs fell, walls tumbled down, and in many cases the buildings lining whole streets were reduced to masses of debris. The inhabitants fled to the open country. A number of persons were injured, but as yet no fatalities are reported.

Arabs Defeated in Africa.

ROME, Dec. 21.—A dispatch from Massawah, Egypt, announces that six companies of Italian troops, under the command of Major Toselli, attacked and defeated the Arabs near Hala. A large number of the natives, including Chief Batagay, were killed. The Italian forces lost ten killed and twenty-two wounded. It was composed entirely of native soldiers, drilled and offered by Italians.

Russian Duties on Cotton Imports.

ST. PETERSBURG, Dec. 21.—The Novosti says that the council of the empire has sanctioned an increase in the cotton import duty. This action follows the news from Khokand on Nov. 24 that Turkistan cotton was threatened by the low price of American cotton, and that the arbitrage committee had petitioned the Russian government to raise the duties on American cotton.

Punished for Soliciting a Bribe.

WHEELING, W. Va., Dec. 21.—In the circuit court Judge Campbell, in the case of Juror Charles S. Goff, accused of soliciting a bribe from the Wheeling Street Railway company, fined Goff \$25 and committed him to jail for ten days for contempt, and officially called the attention of the state's attorney to the other phases of the case.

SIR ROGER TICHBORNE.

Said to Be in an Insane Asylum in New South Wales.

A SENSATIONAL TRIAL RECALLED.

The trial of Arthur Orton to secure the Tichborne baronetcy and his inheritance for forgery—a case which cost the estate nearly \$400,000.

SYDNEY, N. S. W., Dec. 21.—It is stated that the real Sir Richard Tichborne has been found in an insane asylum at Parramatta under the name of William Crosswell.

This dispatch calls to mind one of the most famous cases ever before the English courts, that of Tichborne vs. Lushington, in which the plaintiff claimed the Tichborne baronetcy and estates which were worth about \$1,300,000 a year. Roger Charles Tichborne, the rightful heir to the title and property, sailed from Havre to Valparaiso in 1853, and the following year sailed for Rio Janeiro in a vessel that foundered at sea. A chancery suit was instituted and his death legally proved in 1865.

The claimant asserted before the courts that he had eight of the crew of the foundered ship saved; that he went to Australia, and lived there thirteen years under the name of Castro, but had married under the name of Tichborne. He was accepted by the dowager Lady Tichborne as her son, but the courts decided that he was an impostor. The law proceedings were said to have cost the estate nearly \$400,000.

Subsequently the claimant was indicted for perjury and forgery under the name of Arthur Orton. In 1874 he was convicted and sentenced to fourteen years' imprisonment at hard labor, but in 1884 was released on ticket of leave. He subsequently resided for a time in New York. He delivered some lectures in the United States, always claiming to be the real Sir Roger Tichborne, but public interest in the claimant had died out during his imprisonment, and the ticketing tour he made unproductive and abandoned. He returned to England, and died in poverty several years after the famous trial.

Parsons Recommended.

HARRISBURG, Pa., Dec. 21.—The board of pardons recommended a pardon for Edward Bothams, of Luzerne, murderer of Walter B. McMullen, Philadelphia, embezzler, keeper of a gambling house, and Charles Beymer, Allegheny, keeping a gambling house. It was recommended that the death sentences of George Duko, of Pittsburgh, sentenced to life imprisonment, and the sentence of Robert McKee of Crawford, burglary; Joseph Ragan of Philadelphia, rape; Edward Dillon of Norristown, second degree murder. The case of Peter Kreckman, of Philadelphia, on a charge of murder, was stricken from the list. The case of Hugh E. Dempsey and others was held under advisement, and will be acted on at executive session after the holidays.

The Campanian's Fast Eastward Trip.

QUEENSTOWN, Dec. 21.—The Cunard line steamship Campanian, Captain Haines, arrived off Duane's Rock, from New York, at the entrance of Queenstown harbor at 11:15 last night, having made the passage in five days, nine hours and eighteen minutes, thus reducing her best eastward record—five days, ten hours and forty-seven minutes, made Aug. 31 last—by an hour and twenty-nine minutes. The Campanian came within forty minutes of equalling the best eastward record, made on Sept. 14 last by her sister ship, the Lancia.

Armenians Will Honor Gladstone.

LONDON, Dec. 21.—The Armenian residents of Paris and this city will present a chalice to Mr. Gladstone on the occasion of the coming 8th anniversary of his birth, Dec. 29. His efforts in behalf of Armenia excited warm gratitude from the Armenians, and it has been decided, in view of the memories that have been stirred up by the recent Turkish atrocities, to present him a handsome gift as a slight token of the gratitude felt for his interest in the Armenians.

Minister Breckinridge Will Not Resign.

WASHINGTON, Dec. 21.—Joseph Cabell Breckinridge, brother of Clinton B. Breckinridge, United States minister to Russia, expressed great surprise at a printed rumor that his brother intended to resign his ministry. "I have heard nothing but what you are doing for others, and what we are doing for you. If you are situated where you cannot call on us in person, address your communications to me."
