

VIEWS OF MUNISTER THORSTON.

The Representative of the Republic at Washington Seems to Have Little Faith in the Sincerity of the Ex-Monarch. Her Appeal for Clemency.

HONOLULU, via San Frankson, Fab. 7 .-Ex-Q men Librar, shall not abdicated in favor of the republic. This is by far the most important outcome of the late re-bellion. Las document was drawn up by A. S. Martwell at the request of the exusen. It was presented on the 26th inst. o President Dole. The document, accord-Ing to the wording, was executed freely and voluntarily. If was addressed to the president, and after declaring that "the monatchy is finally and forever ended, absolves all nersons from all and every man-ner of allegiance, or official obligation of luty to me and my heles and successors forever, and I hereby declars to act such persons in the Hawadan Bdandsthat I con ider than as bound in duty and honor hepcoforth to support and sustain the gov-

rnment of Hawali,' rnment of Hawali," In conclusion the exqueen pleads for demoncy for those arround for participation in the recent rebellion.

The answet to Lilluokalani's letter, dgned by Autornoy General Smith, ad-ressed her as Mrs. Lilluokalani Dominis, says that the acceptance of the document does not exempt her from Hability in the late conspiracy. It closes with the assur-ance that her appeal for elemency will re-ceive due consideration.

Minister Thurston's Views.

WASHINGTON, Feb. 7.—Minister Thurs-ton read the Associated Press account of the abdication of the ex-quisen with close interest, and then said. "This action of the ex-queen has a familiar ring to it, and it is a question just how much it is worth. It is right in line with what the rulers of Hawaii have been in the habit of doing whenever they were in a tight place, excep that in this case the situation is worse and the declaration is of course more extreme than has ever been made before. Of course this action of the queen has no formal force whatever. She was nothing more than a private citizen, and had no powers to abdicate, but still it may or may not have some moral effect on the royalists and the Hawalian natives."

Chinese Still Holding Out.

CHEFOO, Feb. 7 .- The Chinese fleet in the harbor of Wei-Hai-Wei is still hold ing out against the Japanese. The Chinese have shelled that part of the town which it was supposed was occupied by the Jap-anese. Three foreigners, named Walpole, Schneil and Thomas, are reported to have been killed or taken prisoners. The comnander-in-chief of the first Japanese army General Nodzu, is reported to have been killed at Hai Cheng. Local papers state that General Tai, commanding the Chinese land forces at Wei-Hal-Wei, is dead and that the situation is critical.


