

Fire Alarm Boxes.

The following list shows the location of the alarm boxes of the Shenandoah fire department:

LOCATION.

- 15-Coal and Bowers streets. 16-Bowers and Centre streets. 17-Belders and Centre streets. 18-Main and Centre streets. 19-Main and Centre streets. 20-Jardin and Oak streets. 21-Main and Poplar streets. 22-Main and Coal streets. 23-Gilbert and Centre streets. 24-Gilbert and Cherry streets. 25-Oak and Gilbert streets. 26-West and Poplar streets. 27-Chestnut and Coal streets. 28-West and Lloyd streets.

To send an alarm open the box, pull down the hook once and let go. When an alarm is sent in the fire bell will sound the number of the box and repeat the alarm four times.

HOW TO LOCATE ALARMS.

If the alarm is sounded from box 15 the fire bell will strike one, then pause and strike five, which will indicate that the fire is in the vicinity of No. 15 box. Every alarm is repeated four times.

PENNSYLVANIA LEGISLATURE.

Senator Kennedy, of Allegheny, May Start the Philadelphia Investigation Room. HARRISBURG, Feb. 18.—The legislative halls are deserted. The lawmakers and attaches have gone home over the sleet and Washington's birthday, and business at the capitol is practically at a standstill. The senate and house will reconvene a week from tonight. Beginning on Tuesday of next week the house will hold two sessions on Tuesdays, Wednesdays and Thursdays. The senate is far in advance of the house, and will continue to hold one session a day for a month yet. Old members say they have never seen so many bills on the calendars so early in the season, and that the greatest dispatch is necessary to clear them before the middle of May. During the week seven sub-committees of the house appropriations committee will visit the various institutions applying for state aid. The committees to investigate the management of the insane hospitals at Norristown and Wernersville will go to work on Thursday. The legislature left with the governor two bills providing for an additional law judge in Washington and Westmoreland counties. The former was vetoed on Saturday and the other has not yet been acted upon. The ten days' limit expires next Friday. It is thought the governor will sign the bill, as Westmoreland is the only county in the state with a population of over 90,000 with one judge, who receives a salary of \$8,000 annually. The county is entitled to two judges by its population. The business of the court is two years behind, and litigants have to be put to much inconvenience and expense by the delay in the trial of cases. The gossip at the capitol is that after the recess a resolution will be offered by Senator Kennedy, of Allegheny, for a senate committee to investigate the affairs of Philadelphia.



In his veto message Governor Hastings declares there is no necessity for the additional judge.
