

RODINGONS ON TRUAL. The Variety Performers Who Are Charged with Murder,

CONFESSION OF THE PRISONERS.

They at First Assorted That the Woman Killed Lawyer Gibbs While Dressed in Male Attire-It Is Now Declared That the Confessions Were Bogus.

BUFFALO, March 12 .-- Clarence Robin son and his wife Sadle were placed on trial yesterday, having been indicted for murder in the first degree for the killing of Montgomery Gibbs, a young lawyer, a year ago. The work of empanelling a jury consumed all of yestorday's session. When the court adjourned at 6 o'clock last evening eleven juryers had been selected, and the semantic set of the selected. and the romaining juror was chosen this norning. The district attorney then bean his opening argument.

The circumstances of this case are as re-markable as mysterious. Mr. Gibbs was valking alone up a residence street bor dered with mansions, brilliant with lights about 10 o'clock in the evening. Suddenly three pistol shots rang out in quick sub-cession, and Gibbs was found dying from a bullet wound in the head, lying in the

scople in the neighborhood. No arrests were made until two months later the Baffalo polloe received word from the police of Cleveland that they had Clarence Robinson under arrest on a burglary charge, and had wormed out from his puls a charge that he was implicated in a Buffalo murder.

Buffalo murder. Robinson's wife, Sadie, thinking that her hushand was to be charged with murder, confessed that the she killed Gibos herself, but refused to give any details. Robinson, but refused to give any details. Roomson, learning that his wife was under arrest for the Gibbs murder, told how he and his wife had gone out to "bold up" somebody that night, Sadie being attired as a man. Heves he has a strong case. The defense will be that the Robinsons made a hogus confession to get out of the Cleveland trouble. Their counsel, Messrs Willard W. Saperstone, of this city, and ex-Judge Lucius Q. Hurdosly, of Mount Vernon, O., purposes to put upon the prosecution the burden of proof, and expeet to clear their clients by reason of the fact that there were no eye witnesses to the orime, and dead men tell no takes.

The Robinsons were variety actors, and for some time before the tragedy had been playing one night stands at small towns throughout the country. Their troups had recently come to grief financially and the pair had drifted into Buffalo a few days

before the shooting of Gibbs. The prisoners were brought into court about 10 o'clock. Sadle was gowned in black. Her short hair had been subjected to the crimping irons until it hung in ringlets all around her odd little head. She wore a plain black skirt. Her jacket was ornamented with eight big square pearl buttons. Her dark blue flat hat was the base from which two black plumes stuck up. She sat in a big chair right at the shoulder of her counsel.

Charence Robinson played the magple in the same happy way. He wore a suit of black, a black four-in-hand tie, and patent leather shoes. His light red hair was care fully trimmed.

River Operators All Agree to the Sixty-Nine Cent Rate. RAILROAD OPERATORS DECLINE. They Declare That It Is Impossible to Pay More Than Fifty-five Cents-Two-thirds of the Striking Miners Gain Their Point. Thirteen Thousand at Work. PITTSHUHO, March 12 .- Thestrike of the ETTIMUMO, March 12.—Theatrike of the miners of the Pittsburg district has reached that point where both sides are chaiming the advantage. The fourth pool operators held a conference Saturday, at which they agreed to pay the sixty-nine cent rate, and nearly all of their men went to work vest relax morning, while the reto work yesterday morning, while the re-mainder resumed this morning.

The river operators, at a meeting yester day afternoon, decide? unanimously to pay the sixty-nine cent rate until the barges in the river are filled and while the boating stage lasts, but the railroad oper-ators unanimously refused to accede to the demands of the miners, and will pay no more than fifty-five cents. They declare that it is impossible to pay more in the present demoralized condition of the mar-ket and with the keen competition from the Winet Winet 6 bit of the first state. the West Virginia fields, the freight rates from that section being so much lower than from here. By the decision of the river operators the

entire district resumed work today, which creates great rejolcing among the men. President Cairns is well pleased, and says that these, together with those who have had the demand granted before, in both rull and river mines, makes the number between 13,000 and 14,000 at work out of the 20,000 in the district. The aldermen were all seen, but they absolutely declined to resign, with the exception of Aldermen Nelson and Stone, who handed In their resignations without a word. City Attorney Murphy, who is generally recog-nized as one of the leading advocates of the present administration, also refused to resign, as did also the city clerk. The committee say they will take the matter to the courts and have them ousted for malfeasance in office.


No Evidence of a Shortage.







There was also found a typewritten letter from United States Senator Vest, dated at Washington and addressed to Governor Flower. ator Vest pleaded for Vallaire's pardon, claiming that his father was a prominent attorney in St. Louis. A bottle contain-ing "knockout drops" was found in the woman's possession. The prisoner gave his name as Albert St. Clair, and his rest dence as Philadelphia.




