WILL PROBABLY BE SHOT.

The Jap Who Shot Li Will Doubtless be

Tried for Treason. WASHINGTON, March 26. - Officials of the Japanese legation say that the man

who shot LI Hung-Chang will be charged with treason, as the assault is not only against the person of Li Hung Chang, but also against the Japanese government. It is probable, also, that the trial will be by court martial, if the martial law existing at Hiroshima has been extended to Shimoneseki. Conviction by court martial would mean that the offender would be shot, while hanging would be the penalty If a civil court convicted him, that form of capital punishment having been substituted for decapitation in Japan. In this connection Japanese officials say the lord high executioner of "Mikado" fame never had any existence in fact.

Mrs. John W. Foster, wife of the exsecretary of state, who accompanies Li Hung Chang in an advisory capacity, has not heard from her husband concerning the shooting. She regards this as favorable, as he assured her he would use the cable freely.

Mr. Foster's last letters came from Shanghai prior to joining Li at Tientsin. Apparently Mr. Foster regarded a peaceful settlement as sure to come. The let ters speak of the care the Japanese government took to prevent a popular out-break when the first peace commission met at Kobe. So fearful was the govern-ment that the anti-peace feeling might bring out some shooting, such as that as has occurred to Li, that all school teachers were directed to teach the Japanese children that it was an essential feature of civilization to accord every respect to

Diplomats here are inclined to believe that the entire peace acgotiations may broken off by the assault on Li by afford-ing a pretext for European intervention. Li himself, however, will prevent a failure of peace negotiations if it be possible for him to do so, as the Empress Dowager has so impressed upon him the necessity of returning to China with a peace settlement that failure, it is asserted, will be folawed by his committing suicide Officials here regard it as settled that Aussia and Japan have reached an understanding, by which the former will extend her territory southward from Vladivostock, thus securing a Pacific harbor, open the year round. This has been an acquisition Russia has long sought, as it gives an eastern ocean outlet to the great Siberian railway. The understanding is regarded as so definite and settled that those diplo nats here who are concerned most with the subject say Japan is now assured of Russian support in urging heavy conces-

WINNIPEG, Man., March 26 .- The rem edial order of the governor general in council, calling upon the government of Manitoba to restore to the Roman Catholles their parcehial or separate schools, reached this city yesterday. It was ad-dressed to the licutenant governor, and by him transmitted to the legislature, which was sitting in readiness to receive it. The legislature was crowded with an intensely earnest gathering when the imincasely earnest gathering when the important document was delivered. It was voluminous, and reviewed all the evi-dence taken ...fore the privy council of England, which body declared that the Catholics of Manitoba had a grievance, and that the governor general in council had use power and authority to grant re-dress by a remedial order. dress by a remedial order.

The tenor and language of the order leaves no opening for compromise. It is a command to Manitoba to submit, and plainly says that if the legislature does plainly says that if the legislature does not obey, the governor general, or more ac-curately speaking, the Dominion govern-ment, will enforce its authority. No defi-filte action was taken last night. After the order head, is the order had been read it was laid on the table for fur ber consideration.

That the order will be rejected may be taken for certain. Of the forty members of the legislature only four or five will vote against the rejection, these four or five being Catholics and representing purely Catholic constituencies.

Premier Greenway, being interviewed last night, said: "We earnestly desire to act with the constitution, but let all people know this trouble is not of our own mak-ing.
