TERRIBLE DUNGEONS.

Experience of an American Citizen in the Sultan's Domain.

NO CHARGES MADE AGAINST HIM.

According to Mr. Manassian's Story His Only Offense Was in Having Become an American Citizen After Leaving His Native Land, Armenia.

New York, May 13.—Cricor Manassian has arrived in this city from Maracchia, accompanied by his wife and child. The facts concerning Mr. Manassian's arrest and imprisonment in Turkey were published some time ago.

"I was then beginning to make plans to return to America. The consul wrote me again April 15, 1894: 'The val informs me that he has sent your papers to Constantinople.'"

"Three days after, late in the evening, seven Turkish soldiers came into the house where I was with my wife and child, and in spite of my protest that I was an American citizen, and that they had no right to arrest me without the information of an American official, they compelled me to go, saying the val wanted me."

"The next day Minister Terrell was informed, and I was released and sent to him. He heard of all I had suffered. It was some days after my arrival that a letter came from Consul Jewett, and both he and the consul at Samsoon have confirmed the outrage and injury inflicted upon me by order of the val."

"I had my wife and child come to Samsoon, and as no man was allowed to come with her I had to take the steamer for London again. I was dumfounded to find that she had no money whatever, all the money that I had (about \$350 in all) and my watch having been stolen by the Turkish soldiers, who remained behind and ransacked my house on the night they arrested me. We sold some of my wife's gold coin ornaments, and with much suffering reached Constantinople. I sent an appeal by registered letter from Constantinople Dec. 12 last to the president of the United States, begging him that telegraphic instruction be sent to Minister Terrell to secure justice for me. No answer came."

"There had not been even a word against me from any Turkish official, and even the chief of police at Constantinople expressed great astonishment that I should have been arrested and put in chains. They took my affidavits and said they would be sent to our government, and that if I managed to reach the United States the matter would be settled from there."

"With much suffering we managed to borrow money and reached Maracchia and there we lived in privations till, by working at my trade all I could, I earned money for passage to the United States. Our consul at Maracchia gave me to understand that they had orders not to protect American citizens who were born Armenians. Is such a thing possible? Who is our government afraid of?"

Death of Ex-Congressman Seelye. AMHERST, Mass., May 13.—Julius Hawley Seelye, ex-congressman and ex-president of Amherst College, died here last evening, aged 70. Dr. Seelye was a member of the Forty-fourth congress from 1874 to 1877. While in congress he opposed the electoral commission and the declaration of the election of Rutherford B. Hayes, though he generally voted the Republican ticket.

Depopulate Battle in Algeria. PARIS, May 13.—A telegram received from Oran in Algeria, reports that a battle has just been fought in the vicinity of the village of Oued, 1,000 men of the Angad and Bedjan tribes having raided the Mouta and Benkhad tribes. The fight lasted several hours and a hundred men and 300 animals were killed.

Maryland's Governor Bereft. BALTIMORE, May 13.—Mrs. Mary Hildogley Brown, wife of Governor Frank Brown, died at the Hotel Rennett. She had been ill with a complication of liver and kidney troubles for several weeks. She leaves two children.

THE DEATH OF DARLING. An Auto-Mortem Statement of the Dead Man Presented.

CHARGES OF POISONING RENEWED.

If a Statement Written by a Dying Man is to be Credited, He Believed He Was Being "Dosed" by His Wife and Her Present Husband.

An Auto-Mortem Statement of the Dead Man Presented.

CHARGES OF POISONING RENEWED.

If a Statement Written by a Dying Man is to be Credited, He Believed He Was Being "Dosed" by His Wife and Her Present Husband.

New York, May 13.—The dying declaration of Edward Irving Darling, the musical composer, was filed with other documents in the district attorney's office in the case in which Mrs. Flora Adams Darling, mother of Edward Irving Darling, accuses Dr. Spranger of having poisoned her son. Soon after the death of Darling, Dr. Spranger married his widow. They are now in California.

The affidavit made by Edward Irving Darling was written partly by himself in the presence of witnesses a few hours before his death. In the statement he tells how in December, 1890, he met with an accident when attempting to secure property for a firm he was with in Detroit. He recovered rapidly and returned to business on March 1, 1891. Dr. Oletz was the surgeon and Dr. Spranger the physician who attended him. He declared that the intimacy between Dr. Spranger and Mrs. Darling, his wife, began during his illness. Concerning this intimacy the letter alleged:

"Prior to her acquaintance with Dr. Spranger we had lived happily. From that date she was a different woman. Where she had been amiable, agreeable and cheerful, she was now petulant, vindictive and arbitrary. I seemed to be the object of her antipathy. She would accuse me of the most absurd actions, and especially delighted to pour her tale of imaginary woes into the ears of any one who would listen."

The statement then recounts his gradual decline in health when with his wife and Dr. Spranger, substantially as given in the statement of his mother, published recently.

Darling said that he fought against sickness and tried to keep up, but it was impossible. His wife, he said, spent much of her time gossiping at Dr. Spranger's office or with his friends. Darling stated that he became worse and Dr. Spranger came to him with a drug which he (Dr. Spranger) said he had received from Paris. A hypodermic injection of this drug drove him crazy. He said that he talked for nineteen hours without ceasing.

The statement continues with the assertion that Darling found his wife had a private letter box. He also discovered that his wife and Dr. Spranger were circulating a report that he was drinking himself to death. It dawned on him that he was not being properly treated and refused to take any more medicine. He began to recover after that. In November he left for New York.

Concluding the statement declared: "In November I was improved, but if any man ever suffered the tortments of the damned, was crushed, hurt, humiliated and crucified, I was at that time by Mrs. Darling. She decided to close the house. My mother went to Mount Clemens. I left for New York. She with the children were to go to Washington. She did not do so. As soon as I left, Dr. S. filed a bill for absolute divorce for drunkenness, non-support, cruelty and desertion, which she expected to obtain with money through default—a suppressed case."

"On Jan. 26 she joined me in New York, came to my rooms of her own volition, and lived with me as a devoted wife until March 1. I had improved in health, gained twenty-five pounds, and was at work on 'Viking.' The day she left I was taken seriously ill, and have fallen slowly but surely. I am dying without hope or hurry."

John Quincy Adams, the brother of Mrs. Flora Adams Darling, of this city, said that the declaration of Darling had been placed in the hands of Assistant District Attorney Battle. He also said that under the direction of the district attorney's office analyses were being made of the medicines taken from phials used in administering drugs to Darling. The result of these analyses will be submitted to the district attorney.

The President's Trout Fishing Trip. WASHINGTON, May 13.—President Cleveland was much refreshed by his day's outing on Saturday, when, with Secretary Morton and Mr. Miller, the commissioner of internal revenue, he spent the day fishing in the vicinity of Leesburg, Va.

Terrible Results of Carelessness. SATLERVILLE, Ky., May 13.—A fatal accident occurred near here in which one and probably two lives will be sacrificed. Two children of Wesley Row tried to start a fire by pouring powder on of a horn containing a pound and a half, on a small coal fire, when the powder in the horn ignited and exploded, tearing one arm entirely from the girl, 10 years of age, and burning her hair and clothing off. She will die. A brother of 6 was standing near, and parts of the horn struck him in the face, knocking out both his eyes and burning off all his clothing and hair. He may recover.

The Troops Were Not Sent Out. DELUTH, Minn., May 13.—Nearly all the military companies of the city were at their armories last night, expecting to be sent to Virginia to quell disturbances at the Franklin mine, where the employees are on strike for an advance of wages.

Fatally Injured by a Pitched Ball. STRONDSBURG, Pa., May 13.—In a game of baseball between the East Strondsburg Normal team and the Wyoming seminary side, Fred Hemmel, who played first base for the latter team, was struck by a pitched ball near the base of the brain, while at the bat and seriously injured. His recovery is doubtful.

Pitted to Accept the Increase Offered. PITTSBURG, May 13.—The employees of the Riverside Iron works, at Benwood, W. Va., held a meeting Saturday night and decided to accept the 10 per cent. raise granted by the company last week, and the men will not go out.
