



Leader of the Workingmen Declares That This Is Necessary in Order to Prevent Starvation Wages for the Men Who Do the Work.

FOR A MONSTER STRIKE.

PITTSBURG, May 27 .- With the collapse of the Pittsburg miners' strike and the ap-parent end of the strike in Ohio and West Virginia comes the question, what are the miners going to do about it? An answer was given to a newspaper representative by Cameron Miller, a national organizer of the United Mine Workers, who said:

"Until the evil naturally corrects itself there is only one thing to be done with regard to the surplus of men in the mines. and that is to restrict production by an nual suspensions, allowing work at the mines to proceed only during certain pe-riods of the year. As matters stand now the coal that is mined comes out a price that gives the digger only a starvation

"It would take years for the evil of sur plus labor on the mining market to correct itself. The miners have come to that point where no other way is open but to say to the operator that if he will not cease sut-ting the throats of thousands of miners in order to gain a small advantage over his competitor then his men must be allowed o mine only a certain amount of coal for

ilm. "What is the purpose of the national convention of miners that has been called to meet at Columbus May 20?" was asked.


"That convention has been called," said Mr. Miller, "to consider the advisability of a strike by all miners in western Penn-sylvania, Ohio, Indiana and Illinois, where the coal fields form the great com-petitive field of the United States. Such suspension would involve about 75,000 men. Personally I am not in favor of the suspension at this time. It is not practicable, and nothing can be gained by it. "Their policy at present is to prepare for

a national strike next spring, which should be begun not sooner than May 1, 1896. At that time business will no doubt have recovered and the miners will be able to justly ask for better wages, if for no other eason than that of the return of better

times "Already the officials of the district have begun the work of reorganization of the Pittsburg miners in anticipation of a fight next year. Should there be a na-tional strike next May, as appears ex-tremely probable, the entire anthracite region east of the Allegheny mountains will be tied up along with the rest of the country. One of the several causes that forced the miners to compromise their national strike last year was the failure of the anthracite men to join the movement, and much anthracite coal was used in place of bituminous fuel. It seems safe to predict that no interstate suspension will be declared by the coming convention at Columbus."

Osvar Wilde Gets Two Years. LONDON, May 27 .- Oscar Wilde was found guilty on the charges of committing immoral offenses, and with Taylor, his ac complice, was sentenced to two years' imprisonment at hard labor. While the jury was out Wilde issued a statement denying the charges. Travers Humphreys, of counsel for Wilde, said: "Now that they have hit their mark, I am certain his health will break down and possibly that tended the prison chapel at Pentonville yesterday. Their hair was cropped, and they were in the prison garb. They will be allowed to see their friends only four times in the year, on condition of their good conduct.

by an Enraged Mob. APPEALS FOR JUSTICE UNHEEDED.

The Pica of a Judge That the Law be Allowed to Take Its Course Laughed at by the Men Who Had Already Pronounced Sentence.

DANVILLE, Ills., May 27 .- Determined to mete justice to two young men ac-cused of attacking a prominent young lady of this place, and fearing to trust their fate to Governor Altgeld in the event of conviction by a jury, a mob took possession of the jail in this place early in the morning and lynched John Halls, Jr., and William Rosce, who were held in \$5,000 bail each for assaulting Miss Laura Barnott.

From midnight, when the crowd first made its appearance at the jail doors, un til the victims were reached, it was the de termined, desperate struggle of a frenzie mob to mete summary justlee, battling against heavy oaken doors and Iron bars nd occassionally halted by the grim stand of a little band of defenders of the law and order under the command of Sheriff Thompson. No amount of parleying on his part and no ploa from him could with stand the mob, which had one object in 710 W

After repeated efforts to break down the which produced little or no effect, the crowd for a moment desisted in their ef-forts to break into the jail. Ed. McCusker stood on the jail steps and addressed the mob, begging them to desist. They laughed him down. Sheriff Thompson, his wife and Deputy Sheriff James Sloan also be-

sought the molt to disperse. F. V. Barnett, the father of the injured girl, said to Mrs. Thompson: "Madam, you never had a daughter assaulted, and her blood demands vengeance." His reply was wildly applauded. At 2 o'clock Sheriff Thompson seut for

Judge Bookwalter, of the circuit court, who addressed the crowd from the jail corridor. He made an carnest plea to let the law take its course. He assured the men that Halls and Royce would receive a severe punishment if found guilty; that the trial jury will do its duty.

But the appeal was in vain. The mob, which numbered fully 1,000, finally broke into the jail, searched out the shivering prisoners and dragged them to a bridge with ropes about their necks. There they were both hanged. They died protesting their innocence.

### Governor Altgeld's Denial.

CRICAGO, May 27 .- Touching the charge made by one of the speakers at the double ynching at Danville, Ills., Governor Altgeld said: "The newspaper men know that the records in the capitol at Spring-field show that I have fallen far below the average of pardons and commutations granted each year, while the number of prisoners has nearly doubled and conse quently the number of application for pardons has nearly doubled."

### Punishing the "Sooners."

ORLAHOMA CITY, O. T., May 27 .- The penalty for "soonerista" is being indicated already. Of the 237 applications offered at the land office for filing only twentyseven were accepted. The others were re-jected on account of the applicants hav-ing entered the Kickapoo country in March, 1893. This is causing intense excitement here, and will affect the great majority of men who made the race for land. Nearly every man in this country has been across the Kickapoo country since that date on business or pleasure. If the secretary of the interior should up-hold the action of the land office it will ause numbers of contests.

His wife and friends in New York were delegraphed, and are now en route on a special train.

Big fire in a Pennsylvania Village. SCRANTON, Pa., May \$7.-A large por-tion of the business center of Dalton, ten north of this town, was destroyed mills north of this town, was determined by fire early yesterday morning. The backet brigade was insufficient to stop me headway of the fiames, which started in the store of F. L. Van Fleet, and burned for six hours. There is no fire company in the place. Mr. James Boardman fell through two floors of a building and re-ceived serious injuries. The estimated loss is \$50,000.

### Bought a Railroad for \$450,000.

MALONE, N. Y., May 27.-The Northern Adirondack railroad was sold here on foredosure of the Franklin Trust company mortgage and was bid in by President Packard, of the trust company, who purchased the entire road, its franchises, tele graph system and appurtenances, for \$450,-000. This is subject to the first mortgage of \$77,000 and interest. The road runs from Moira to Tupper Lake, fifty miles.

### Emptied Five Barrels of Whisky.

SCRANTON, Pa., May 27 .- Patrick O'Con-nor was indicted by the grand jury for statutory burglary. On Friday night O'Connor entered the liquor store of John Langan, of Olyphant, opened the faucets of a number of liquor barrels and allowed the contents to run on the floor. About five barrels of whisky ran through the open faucets and formed a large pool on the cellar floor.

### Drank Chloroform for Whisky.

BRISTOL, Tenn., May 27 .- Three young men in Lee county, Va., J. Burton, Ed-ward Golligher and Samuel Jones, went behind a counter in a store where moonshine liquor was usually kept secreted for their benefit and others. They made a mistake and drank from a bottle containing chloroform. As a result only one, Golligher, lives to tell the tale.


