Indians Peaceably Retire.

MARKET LARE, Idaho, Aug.5.-A special telegram from the Bannock agency says Indian Agent Teter wired General Coppinger from the reservation that all the Indians that had been absent from the Fort Hall reservation have returned, and that all is quiet. Adjutant General Stitzer and Colonel Foote, of the Wyoming National Guards, and the representatives of Governor Richards have arrived here, having come direct from Jackson's Hole. General Stitzer says the tough characters in Jackson's Hole represent only a very small proportion of the population. He says the Indians are by no means blamsless in this affair, as claimed by Agent Teter.

Murdered His Baby Stepson.

SHAMORIN, Pa., Aug. 5 .- John Shor-bough, of Enterprise, is wanted for the murder of his 3-year-old stepson. The little fellow was running to meet Sharbough, with extended arms, as the latter returned from work. Shorbough picked up a club and struck the little one on the head, repeating the blows until the child was unconscious. Shorbough is employed as a miner and is about 30 years of age When he married, a year ago, his wife had the little son. Although the stepfather manifested a strong dislike to the child the latter was very much attached to him. The murderer has eluded capture.

Twenty Rioters Killed by Troops.

TEHERAN, Aug. 5 - The scarcity of bread and the closure of the bazars to prevent disorders has led to serious rioting in Tab The troops dispersed the rioters, recz. twenty of whom were killed. The mob carried the corpses to the Russian consul-ate and demanded protection against the soldiers. The consul thereupon visited the governor, who promised a reduction in the price of bread. Nothing has yet been done in the matter, and the tro were still firing on the mob when this


Lord Salisbury's Sweeping Demand.
