

The Gonzalez Case Quashed. WASHINGTON, Nov. 2 .- The state department has received a telegram from consul general at Havana stating that the case of Martinez Gonzales has been quashed and his release ordered by the captain general, and that the case of Vic-toriano Valit Perez has been transferred to the civil courts. Gonzalez was arrested on suspicion the latter part of September by the civil authorities at Sagua la Grande, and was released after five days' deten-tion. He was immediately rearrested by the military authorities and thrown into prison. He claims to be an American citi-zen. Mr. Perez also claims to be an American citizen. He was arrested for "pro-posing treasonable acts."
