It was that of Matthew Callinan, and it was buried in the mud directly where the trucks of the motor had been. The body of Miss Martha Sauernheimer had been recovered earlier in the day. The search for bodies has now been abandoned.

### READING REORGANIZATION PLAN It Includes a Twenty Per Cent. Assessment

on Common Stock.

NEW YORK, Nov. 10 -- Copies of the reorganization plan for the Reading have been furnished to a few important interests in advance of the general publication. From the discussions occasioned by the forecast it is gathered that the common stock is to be called upon for a 20 per cent. sessment, new common stock, share for share, to be given to those who pay the as-sessment. There are now outstanding between \$40,000,000 and \$50,000,000 of this security.

The total funded debt is \$175,000,000, and of this \$145,000,000 is on the Philadelphia and Reading road proper. The general mortgage 4 per cents, to the amount of \$44,000,000, are followed by three sets of inne bonds of \$23,000,000, \$16,000,000 and \$17,000,000 in the first, second and third series respectively. There is also a batch of #25,000,000 in deferred incomes.

These great issues of some \$50,000,000 in all are very extensively held, and they are all to be wiped out, according to the plan reported. In their stead two series of preferred stock will be created. There is to be an assessment in cash of 20 per cent, on all series of bonds, and each first income bond of \$1,000 will get thirty shares of first and 100 of second preferred stock; each \$1,000 second income bond will get twenty shares of first preferred and sixty shares of second preferred stock, while to each \$1,000 third income bond will be alloted ten shares of preferred, sixty shares of second preferred and sixty shares of common stock


