TOLEDO, Nov. 97 .- A terrific wind storm

At Toledo, O., It Blew at the Rate of Eighty-one Miles an Hour-Street Cars Stalled in the Streets of Chicago-No Fatalities Reported.

CHICAGO, Nov. 27 .- The storm which preceded the present cold snap here was The wind blew a gale. Railroad traffic was greatly delayed, while the street car companies were forced to abandon some of their minor lines, devoting their energies to keeping the main lines open. Dispatches received here show the same state of af fairs throughout Illinois. Quincy reports a howling blizzard, with snow falling fast, impeding street and railroad traffic, and similar reports come from Peoria, Fair-

Passengers on the Calumet Electric Street railroad were snowbound in a deso-late portion of the city, and some of them compelled to remain all of Monday night in the cars, being unable to reach their homes in South Chicago. Car No. 17, which runs over South Chicago ave-nue, was stalled at 10 o'clock Monday night and remained there until morning with five passengers, in addition to the motorman and conductor, on board. A car of the Seventy-fifth street line shared a similar fate near Stony Island avenue, as did also a south bound car at South Chicago avenue and Ninety-seventh street, and another at Sixty-seventh street and Vernon avenue. Each of the cars carried passengers, who spent the night aboard. When the cars were first stalled they carried the usual number of passengers, but as the hours passed and no indications of progress were given the majority of the passengers left the cars and continued the remainder of the journey on foot. Some, however, who lived a great distance, re-fused to leave the cars, preferring to spend the night in them to facing the storm. On Lake Michigan the gale was very

severe and the sea running very high. Comparatively few vessels are out at this time of year, and it is not expected that there will be much loss of life, if any.

About 3 o'clock yesterday morning the steamer J. Emery Owen ran aground with two consorts, the schooners Michigan and Glencoe. Just how the pilot lost his bearing is not yet known, but was undoubtedly due to a blinding snow storm. In all there were between fifty and seventy-five people on board the three vessels, all of whom were resoued. Communication has been established with a grounded vessel off Glencoe, and it has been ascertained that none of the sailors are dead, though all are suffering terribly from exposure

Coal Boats Wrecked.

LOUISVILLE, Nov. 27 .- No loss of life has been reported as a result of Monday night's gale, but much damage was done among the Ohio river towns in Kentucky and Indiana. In Louisville several residences were unroofed, chimneys were leveled and signs demolished, but across the river the damage was more severe. At Jeffersonville many barns were wrecked, and along Front street residences were unroofed and windows blown in. At Arctic Springs

Three shanty boats at Port Fulton were sunk, and Captain Duffy's coal fleet was torn from its moorings, and twenty-five empty boats lost. ARMENIAN MASSACRES. It Is Estimated That Fully 40,000 Were Slain by Turks.

THE PROPERTY LOSS \$50,000,000.

The Loss of Life Will be Increased by Starvation This Winter-Peculiar Beply of Turkish Authorities to a Private Request for Information.

CONSTANTINOPLE, Nov. 27.-Now that matters seem to be quieting down again here and in the Asiatle provinces, people are beginning to form estimates of the amount of damage done and the number of lives lost during the recent disturbances. Well informed Armenians esti-mate the losses through the events which have just taken place in Anatolia alone at \$50,000,000 and the number of victims at 40,000. Of course these are Armenian estimates, but there seems good reasons for believing that the property destroyed, the number of lives sacrificed and the terrible outrages committed are far beyond any-

thing hitherto estimated or described. But this is not all. People competent to pronounce an opinion upon this subject say that with the coming of winter there will be very many more deaths from ex-nounce and families and that more the posure and famine, and that even the prompt collection of relief funds, food and clothing cannot avert much loss of life and great suffering. Famine is threatened

in a number of districts, and there seems to be no way of preventing it. Details have been received here regard-ing the outbreak at Marash on Nov. 19, showing that the massacres were of the most terrible nature. The missionaries declare that many hundreds of people were

killed and that all the school buildings were burned to the ground by the rioters. A telegram has been received here from Kharput explaining the manner in which the recent destruction of American mission property occurred. The American mission buildings at Kharput were set on fire sep arately, according to the telegram, in the presence of the soldiers, but the college building was saved. 

LONDON, Nov. 27 .- The Times publishes an article written at Erzeroum, dated Nov. 9. The correspondent says: "The massacre here certainly occurred by the order of the authorities, and this order must have emanated originally from the central authorities at Constantinople. Much circumstantial evidence can be produced to corroborate this statement."

Jail Breaking Prevented.

THENTON, Nov. 27.—A proposed jail de-livery was nipped in the bud at the state prison yesterday, and John Langenburg, William Speer and William C. Houself, the convicts who had prepared the scheme, were put in dungeons. A fellow prisoner informed Head Keeper Patterson of their plans, and in their cells were found two prison suits dyed to another color, and a rope ladder thirty feet in length. The men were employed in the cocoa mat shop, and secreted coloring matter used there to dye their clothing. The indder was made of cocoa strands. They were walting for a dark or foggy night to make the break. Langenburg and Speer are from Morris county, where they were sentenced last February to ten years for breaking and entering. Housell is doing a fifteen year term for burglary in Middlesex county.

Convicted of Criminal Assault.

NEW YORK, Nov. 27 .- Walter L S. Langerman, whose sensational trial for crim-inal assault on Miss Barbara Aub, has created a stir in this city for the past week, was convicted yesterday afternoon. The jury returned a verdict of "guilty of rape in the first degree." The extreme penalty for the offense is twenty years' imprisonment. Langerman was remanded until Friday for sentence.
