

Only one fact remains undi-puted, and that is that Edward Farr, en-gineer of the Reading train, who died with his hand on the throttle, disregarded the danger signals and thundered on to his own destruction. Inst desperate effort to reverse his engine when he saw that a collision was immi-nent, but then it was too late. Suspicion has been strongly directed against George F. Hanser, night operator at the tower where the wreck occurred, but nothing more than suspicion. 




