

FATAL FIRE IN MONTREAL. Three Firemen Killed and Six Others Recrive Serious Injuries.

MONTHEAL, Que., Oct. 17.—Three firs-men were killed and six badly injured at a stubborn fire yesterday afternoon at the chemical warehouse of Gilmour & Co. The dead firemen are: Edmund Laporte. Harry King and Sylvin Charpentier. The body of the latter is still buried under tons of debris. The firemen think an unknown civilian is also under the debris. Of the injured the only one likely to die is

The fre-men fought the fire courageously, and after an hour's work seemed to have the upper hand. At this stage the firemen were distributed in all parts of the build-ing, and were speedily drowning out the flames, when with a certible crash the sec-ond floor gave way and fell to the floor be-neath. The men who were on top escaped half suffocated and blesding from many wounds, but the men below were crushed under tons of timber and goods. The loss to property is in the vicinity of \$100,000.
