# MRS IRWIN ACQUITTED. NEW JERSEY LEGISLATURE.

MATTHEWS DECLINED TO TESTIFY.

The Man Condomned to Death for Rilling Farmer Irwin, for Which Crime His Wife Was Being Tried as an Accessory, Bluntly Refused to Inoriminate Her.

BALTIMONE, Jan. 10 -Mrs Emma C. Irwin was yesterday afternoon acquitted of the charge of being an accessory with George Matthews, her paramour, in the murder of her husband, James J. Irwin. The prosecution found itself powerless to place before the jury evidence that would show collinsion when Matshews, who is under death sentence for the crime, re-fused point blank to testify in the matter.

After this the state closed its case, which was given to the jury without argument. A verifict of not guilty was rendered, the jury not leaving the box. Matthews, the confessed murderer of Irwin, was the last witness summoned for

the pressoution, and when tandared the Bible that he might be sworn refused to touch it. He was then asked to affirm, which he likewise refused to do. "Do you maan you won't toutify in the case?" asked Judge Wickes. "I won't have any-thing to do with it," answord Matthews. "I think I have done all that I had any right to do. They would not let me tes-tify down there, and I won't testify here.

That much is certain." Under the cir-cumstances, the day of Matthews' execu-tion being near at hand, Judge Wickee did not countil him for contempt. James J. Irwin was a farmer at Allen's Fresh, an isolated village of Charles county. From childhood Mrs. Irwin had shown a liking for George Matthews, an syster dredger, and about her own age, who lived near her home. May be Connected by a System of Deep Waterways.

SPECIAL COMMISSION'S REPORT.

It is Entirely Peasible to Construct Canals and Develop Channels That Will Employ Vessels to Sail from the Lakes to the Sanboard.

WASHINGTON, Jan. 19 - The president yesterday sent to the house the report of the deep water ways commission, conduc-ing of President Angel, of the University of Michigan, John E. Rossell and Lyman E. Gooley, which was appointed in 1896 under a resolution introduced by Sonator Vilas of Wisconsio, for a preliminary in-quiry as to the pracilcability of water ways between the ocean and the great lakes. The conclusions of the commission follow.

It is entirely fensible to construct such canals and develop such channels as will be adequate of any scale of navigation that may be desired between the great alces and the seaboard, and to con through the same domestic and foreign erce, and that it will be wise to pro vide for securing a canal of a navigable depth of not less than twenty-eight feet. Starting from the heads of Lakes Mich-

Igan and Superior, the most eligible route is through the several great lakes and ibeir intermediate channels and the pro-posed Niagura ship canal (Tonawanda to Olcott) to Lake Ontario. The Cauadian biological to Lake Original. The Canadan seaboard may be reached from Lake On-tario by way of the St. Lawrence river and the American seaboard may be reached from Lake Ontario by way of the St. Lawrence and Lake Champlain and the Hudson river, or by way of the Oewego-Onsida-Mohawk valley and the Hudson rivor.

The alternative routes from Lake Ontarlo to the Hudson river require com surveys and a full development of c onsiderations to detormine their relative availability.

A moderate control of the level of Lake Erie and of the Niagara river above Tonawanda may be justified in connection with the Niagara ship canal, the determination in this matter to rest on a full examination of the physical condition The policy should contemplate the ultimate attainment of the largest successful capacity, and all works should be planned

on this basis, and the actual execution should conform thereto, in so far as the works may without prejudice be progressively developed with the actual demands Po.

It is practicable to develop the work in separate sections and the several socilors in part by degrees, each step having its sconomic justification, so that the bouchts should follow closely on expenditures without awaiting the completion of the system as a whole. The completion of the entire system as quickly as proper pro-jects can be matured and scouomically excuted is fully justified.

conted is finity justified. The Niagara ship canal should be first-undertaken, and incidentally the broad-ening and further despening of the inter-mediate channels of the lakes, the same being in the logical order of development and also requiring the least time for consideration.

The commission estimates that the com-plete surveys and investigations, with measurements of the outflow of the several lakes and full investigation of collateral questions, will cost not less than \$600,000 and require some years of time.




