CHANDLER AND BIMETALLISM.

Republican Senator Introduces His International Agreement Resolution.

WASHINGTON, Feb. 3.—The feature of the senate proceedings yesterday was a very spirited debate on the conference report on the immigration bill. Mr. Gibson, of Maryland, opposed the report, and Mr. Lodge defended it. After two hours' struggle the report went over and the Nicaragua canal bill was taken up. Mr. Vilas continuing his remarks. Mr. Taylor, of Colorado, also entered the debate in opposition to the measure. Early in the day Mr. Chandler introduced a resolution stating that the government should steadily direct its efforts to secure and maintain the use of silver as well as gold as standard money, with free coinage of each, under international agreement.

This day in the house was very dull, the whole day being devoted to appropriation bills. The diplomatic and consular bill was passed and considerable progress was made with the District of Columbia bill. The bill as passed carries \$7,750,000. Resolutions regarding the normal arrangement of the electoral vote of the last presidential election on Wednesday next were adopted.

Keelley Cure Declared Invalid.
MADISON, Wis., Feb. 3.—The Keelley cure was declared invalid by the supreme court yesterday. The test case came from Milwaukee in the form of an appeal from the decision of the circuit court, which was favorable to the Wisconsin Keelley institute in a suit brought against Milwaukee county for \$100 for the treatment of a patient committed to the institute by the county court under the laws. The constitution of the county attorney was that the law provides liability for the county, and directly taxed the citizens. It was therefore void.

Wholesale Murderer Captured.
SAN FRANCISCO, Feb. 3.—The Swanhill, from Newcastle, Australia, arrived yesterday. Frank Butler, the Australian murderer, was arrested and brought ashore. Butler is accused of a number of crimes which cannot at present be proved against him, although evidence of his guilt are being unearthed every hour. He is known beyond doubt, however, that at least two men, Arthur Thomas O. Preston and Captain Lash Walker, met their deaths at his hands within the past few months.

Sickles May Be Pension Commissioner.
CHICAGO, Feb. 3.—An Illinois man, who has been an applicant for the position of pension commissioner under the McKinley administration, says that he has good reason to believe that General Daniel Sickles, of New York, will be given the appointment. It is said that although General Sickles is not an applicant for the place, the appointment will be offered him, not as a recognition of the sound money Democrats, but on the ground of his personal fitness for the place.

The New Jersey Legislature.
TRENTON, Feb. 3.—The house and senate both had a busy day yesterday, and practically nothing was done beyond the introduction of bills with the exception of the passing by the senate of Senator Hood's bill, providing that official election certificates shall hereafter be in the name of the governor. This was explained in that the envelope and official ballot get mixed up because of being the same color. Both houses adjourned for the balance of the week.

Four Men Sentenced to Death.
SANTA FE, N. M., Feb. 3.—Frank and Antonio Borrero, Santiago Alard and Patricio Valente were sentenced to death yesterday for the murder of Frank Chavez, former sheriff, and whose conviction was recently affirmed by the United States supreme court, have been resented to be hanged Feb. 23.

The Stricken Senators.
WASHINGTON, Feb. 3.—Senator Harris had a very bad cold yesterday, and is said to be doing well as can be expected. He is still a very sick man. Senator George is improving, and if his condition continues to be better, his physicians hope he may be taken to his Mississippi home soon.

THE FAMINE IN INDIA.

Sad Tales of Destitution from the Stricken Districts.

FOOD SUPPLY NEARLY EXHAUSTED

The Minimum Dole of Food Given to the Starving People Only Sufficient to Keep Body and Soul Together, and Too Little to Build Up the System.

LONDON, Feb. 3.—William Lord Sandhurst, governor of Bombay, has sent a cable message to the effect that the famine plague patients patronizing the hospitals more freely than at the time of the first outbreak of the epidemic. In the section where the disease has its strongest hold in the beginning it is now being suppressed, but it appears to be extending to new portions of the Bombay presidency. In places most recently infected by the plague the mortality is evidently not so great. In the city of Bombay the number of deaths diminished during the week ending Jan. 30, and the feeling at that place is one of great hopefulness. In the city of Poona, Bombay presidency, fifty-eight cases were reported, but a late account is to the effect that forty-eight cases were announced in a single quarter of the town.

Governor Sandhurst reports that the number of deaths from the plague at Karachi reached 108 for the week ending Jan. 22, diminishing to 178 for the week ending Jan. 29, decreasing in the two worst quarters of the town, but increasing in the two sections formerly least infected by the epidemic. It is estimated that one-fourth of the total population of the city has left Karachi on account of the plague. The only death from plague reported from Sind, just outside Karachi, was said to be those of travelers. Generally speaking this same thing may be said to be true of other towns of the Bombay presidency besides the cities of Bombay and Poona, with the exception, however, of the towns of Dandora and Coria, and their suburban villages, and the unhealthy place of Bhiwand, in the Thane district.

The special correspondent of the Associated Press, who is inquiring into the famine ravaging Karachi, the largest district of the central province, having a population of 1,500,000, finds the situation very grave. Karachi is the center of the rice growing industry, which is the only crop grown, and as it has failed there is a total extinction of food stuff in the locality, and real famine exists. About 1,300 villages are affected. The relief works have given employment and the means of subsistence to 50,000 persons.

Of the worst parts of the district in Dharwad, thirty miles from Karachi, where lamentable conditions prevail. Many people have already died of hunger and many others are dying. The staff employed in the work of relieving the sufferers is inadequate to cope with the enormous area. If the work of relief had been properly arranged earlier the mortality would have been less, as the rains are increasing the spread of disease. It will take three good years to recoup the losses in that district.

The poor state of the district, on account of the condition of the people. Besides the professional beggars they are crowded with laborers, reduced to the last stage of skeletons. Their bodies are emaciated and their eyes are hanging in their sockets. Others have swollen stomachs, the sign of acute privation. It is found that the cattle and goats, and fowls, usually the women are unable to do anything, and the women are in the same condition.

One woman, who has long been confined, has been attacked with rheumatism, caused by exposure, and is paralyzed. Her baby is horrible to look at. Its limbs are about the size of pipe stems, and its sunken eyes have a most piteous look. No provision has been made for the case. The minimum dole of food is only enough to keep body and soul together. It does not suffice to build up the system again.

Some horrible sights are witnessed. A man, with both legs cut off, was a mass of white scales, and others were nearly as bad. The condition in the district is the worst yet seen. There is urgent need of funds. If it is not soon the people will be utterly incapable of producing any more food. The last year's food supply in the district will soon be exhausted.
