

Manila, April 10 .- The expedition of 1,500 men, under Major General Henry W. Lawton, which started Saturday night with the intention of crossing Laguna de bay, capturing the town of Santa Cruz, on the eastern shore of the lake, and then sweeping the country to the south, consists of 200 picked of sharpshooters chosen from the various regiments. Hawthorne's mountain battery, Gales' squadren, three troops of the Fourth cavalry, unmounted, with Bronke's and Tappen's battalions of the Fourteenth infantry, Linck's battallon of the First Idaho infantry and Frainor battallon of the First North Spring Dakota infantry, under General King. The men were all in high spirits and




