GERMAN VIEW OF COGHLAN. Kalser's Government Satisfied With

Secretary Hay's Disapproval. Berlin, April 25.-John Hay, secretary of state of the United States, has expressed to the German ambassador at Washington, Dr. Von Holleben, his emphatic disapproval of the conduct of Joseph B. Coghlan, of the United States cruiser Raleigh, in uttering in a recent speech sentiments calculated to irritate the German government. In official circles the Cohlan incident is regarded mildly as an "ausfluss der weinlaune" (expression of wine humor). A representative of the foreign office said:

"The American government has promptly and efficiently done all we could reasonably expect. This alone, even if it were not for other indications, shows us that the American govrnment in no way identifies itself with the utterances of a solitary of-



the lynching of the negro. Said he "Gentlemen, this negro is innocent Hose said Lige had promised to give him \$20 to kill Alfred Cranford, and I believe Lige has not had \$20 since he has been on my place. I do not ask you to liberate him. Hold him, and if the courts adjudge him guilty, hang him.

Mr. Thomas called attention to the fact that Strickland had voluntarily told of having seen Hose on the night of the murder, and finally a vote was taken, which resulted in a unanimous decision to let him live. With the assurance that Strickland would be taken to Fairburn jall the major returned to his home. A mile further on






