

## CARS WRECKED. SCHOOL

An Imperfect Railway Switch Causes Considerable Damage.

penal clause of the Act is as follows: 'Any tax collector failing to comply with the re-quirements of this Act shall be deemed guilty of a misdemeanor and, upon convic-tion, shall be sentenced to pay a fine not ex-ceeding one hundred dollars.' 
