ALL CLEWS FAIL Arnold Family Lawyer Tells of Mother's Quest.

## THEY BELIEVE SHE IS DEAD.

Lorenzo D. Armstrong Makes a Statement of the Missing Girl Case and of the Efforts of Her Parents to Find Her.

New York, Feb. 1.-The mother of Dorothy Arnold is in Europe conducting with the assistance of family friends a search for the girl who vanished Dec, 12. Mrs. Arnold has consinued to believe that Dorothy went abroad, although other members of the family came eventually to the conclusion that she was dead.

It was Dorothy's mother who called with her oldest son, John W. Arneid, on George S. Griscom, Jr., at Mr. Griscom's hotel in Florence, Haly, Jan. 15, a month after Mr. Griscom had cabled that he knew nothing about Dorothy's whereabouts or motives for leaving home and renewed request for information. Lorenzo D. Arm strong, who has superseded his low partner, John S. Keith, as the commumicator between the family and th newspapers, said that while Mrs A sold obtained no news from the Pittburg clubman she had been unwill: to return home.

Mr. Armstrong says that there at pears no good reason for longer will holding the facts that folders and sailing schedules of half a dozen Atlantic steamship lines were found among Dorothy's papers and letters and that this fact, coupled with discovery of letters from Mr. Griscom, had led the family to believe for a time that Durothy had gone to Europe. That was Mrs. Arnold's conclusion, Mr. Armstrong said, after nothing had come of shadowing a young man in this city who had been attentive to her daugh ter.

In speaking of Mrs. Arnold's tri; abroad in search of her daughter Mr. Armstrong said that he did not believe she had found a trace of the missing girl.

"I want to say that she doesn't know any more now where her daughter is than she did when she sailed," he deelared. "although it was her original impression that if Dorothy had not come to harm in this city she might have gone to Europe. I cannot say when Mrs. Arnold will return.


"'I will not have any publicity,' she said before starting, 'and if this gets into the papers I shall never come back.'

"I want to say now," Mr. Armstrong continued. "that after fifty days' in vestigation I have made up my mind that Dorothy came to her death some where outside of New York city. speak entirely for myself, for it is like by that some members of the family would not want to make that statement.
