King, vice president of the Jones-Laughlin company of Pittsburgh, told the senate finance committee of the relations that existed between the United States Steel corporation and the independent manufacturers prior to 1904, when it was decided the arrangements "might be in violation of the Sherman anti-trust law."

MR. KING SAID THE INDEPENDENTS AT WAYS FOLLOWED THE REDUCTIONS IN PRICES OF THE STEEL CORPORATION AND THAT "THE CHANCES WERE THE INDEPENDENTS WOULD FOLLOW AN INCREASE." John G. Butler of Youngstown, O., appeared before the committee as the chief spokesman for the pig iron producers. He said the pig iron duty in the Dingley bill was cut 50 per cent in the Payne-Aldrich bill, and Underwood proposes another cut of 50 per cent. He declared that pig iron was produced in Germany and England 85 cents cheaper than in this country and that the Underwood duty of \$1.50 a ton would cause distressful conditions in the industry.

GEORGE A PEACEMAKER.

British King Suggested German Negotiations, It Is Said. Berlin, Feb. 22.—The present rapprochement between Germany and Great Britain is due altogether to the efforts of King George of England, who, according to an apparently inspired article in the Lokal Anzeiger, is following in his father's footsteps as a great peacemaker. The article in the Lokal Anzeiger says it was King George who bronched the idea of a frank discussion of the tension between the two countries and suggested that such "conversations" would probably have a good effect. He talked of the matter before he sailed for India, and shortly after he returned Viscount Haldane, the war secretary, left London on his momentous trip to Berlin.

The writer of the article in the Lokal Anzeiger says the talks between Lord Haldane and several official Germans, including the kaiser himself, were far more favorable than either side had dared to hope. The friendly and optimistic statements by Premier Asquith in the house of commons and Chancellor Von Bethmann-Hollweg in the reichstag followed, and now the foreign office of both countries are at work on pourparlers which it is thought will have an important result.

LATE LORD LISTER WAS GRAND OLD MAN OF SURGERY

Was Famous as the Discoverer of Antiseptic Treatment.

Lord Lister, the "grand old man of surgery," known to fame as the discoverer of the antiseptic treatment method in surgery and the first English physician ever accorded the honor of knighthood, died recently at London near the end of his eighty-fifth year. Sir Joseph was often referred to as the most famous living surgeon. His elevation to the peerage came in 1897, and he has been honored in many other ways for his services to humanity.

His father, Joseph Jackson Lister, was a scientist, and the son was imbued early with scientific tastes. After completing the course in the University of London in 1847 he entered his medical studies at University college, where he came under the influence of Sharpey and began his surgical studies. Following graduation he went to Edinburgh to study surgical practice there, became greatly attached to Professor Syme and married his daughter.

He was appointed regius professor of surgery in the University of Glasgow in 1860, and it was while there that, shocked by the prevalence and fatality of the so called hospital diseases, his work in connection with antiseptic surgery was begun. He always acknowledged the influence of Pasteur's work in the development of his ideas.

In 1877 on the death of Sir William Ferguson he was appointed professor of clinical surgery at King's college, London. He was honored by nearly all of the prominent universities of Great Britain. He served as president of the Royal society and of the British Association For the Advancement of Science.
