MORE STOLEN CARS BEING RECOVERED
The automobile title law of 1923 has aided in the recovery of stolen automobiles during the past year to a marked degree according to Benjamin G. Eymon, Registrar in the State Highway Department.
In a statement this week, Mr. Eymon said:
"There is no question but that the operation of the title law in Pennsylvania has been very material in effecting the number of recoveries. For without a certificate of title to a motor vehicle the thief is powerless to dispose of it in this state unless of course, he sells it to some person with whom he is in collusion, and his only recourse is to take it to some other state."
During the first six months of this year, 2,916 thefts of motor cars were reported and 3,155 cars were recovered. Last year during the same period there were 2,569 thefts and 1,965 recoveries.
Although the title law became effective last November, its operation had not had a chance to function until the new year, when the 1924 registration process began.
HEAVY SENTENCES GIVEN BY COURT
At the forenoon session of the regional weekly court held at Ebensburg, the following waived findings of true bill by the grand jury and were sentenced as follows:
Arl H. Freeman, charged with larceny, was remanded to the county jail until his case is further investigated.
Leslie Fisher, charged with larceny, two counts, was ordered to pay the costs, make restitution and serve from one to two years in the county jail.
Harry Allen, charged with larceny, was given the costs and undergo imprisonment in the county jail for a period of four months from date of incarceration.

Walter Maleky, charged with felonious assault, was sentenced to pay the costs and serve two months in the county jail.
Leroy Hartz, charged with larceny, was directed to pay the costs and serve from three months to one year in the county jail.
SUFFERS BROKEN BACK WHILE AIDING OTHER
Clearfield, Aug. 18.—While endeavoring to rescue his brother, Clair, who was caught under a fall of rock at his work in the mines and had both legs badly crushed, John Langley, also a miner, was crushed underneath a second fall of rock and as a result of injuries sustained both brothers are lying in a serious condition at the Clearfield hospital. John Langley suffered a fracture of the spine.
Unable to walk, Clair Langley dragged himself 100 feet, climbed into a mine motor, drove up to his injured brother and placed him on the conveyer after much difficulty. Clair ran the mine motor to the mouth of the mine, where both men were placed in

COUNTY DETECTIVE MAKES TWO RAIDS
County Detective Ed White, of Barnesboro, raided two alleged moonshine joints in the Cresson vicinity on Thursday last arresting Frank Sanders, of Munster township, and Robert Bloom, of Cassinira. A 20-gallon still and 11 barrels of mash were confiscated at the Sanders home. Informations were made against Sanders and Bloom before Judge Veil, of Cresson, charging each with violation of the liquor law. Both were released upon posting \$1,000 bail for their appearance at the September term of Criminal Court at Ebensburg.
At the last session of Criminal Court Bloom was indicted on a charge of violating the liquor law, but was released on payment of the costs.
