INCREASE IN RATES OF POSTAGE ARE EFFECTIVE

April 15th Will Witness Some Changes in Local Post Office Rates.

Postmaster Thomas Powell of the local post office has given the condensed report of the increase in rates of postage effective on April 15th. The rate of postage on all cards will be two cents each. There will be no charge for the rate of government-post cards on any other mail of the first class or under shall constitute third class mail and shall be carried at the rate of 15 cents for each two ounces, or under eight ounces, which will retain the rate of 1 cent for each ounce.

The present fourth class rate according to distance of zone will apply to all matter weighing more than eight ounces, except that of the first class or under shall constitute third class mail and shall be carried at the rate of 15 cents for each two ounces, or under eight ounces, which will retain the rate of 1 cent for each ounce.

There will be a special F. A. M. charge of 25 cents for parcel post. Parcel post will be carried at the rate of 15 cents for each two ounces, or under eight ounces, which will retain the rate of 1 cent for each ounce.
